SUBJECT: Increase Purchase Order for Refurbishment of 2008 Impel 75' HD Ladder Truck (Ladder 2)

REQUEST:

It is requested that City Council authorize an increase to the purchase order for the refurbishment of the Fire Department's 2008 Pierce Impel 75' HD Ladder Truck to Halt Fire Inc., 50168 Pontiac Trail, Unit 5, Wixom, Michigan and Pierce Manufacturing, Inc., Weyauwega, Wisconsin in the amount of \$52,362.00 for a new not-to-exceed contract amount of \$222,890.60.

REASON FOR PURCHASE:

At their February 22, 2021 meeting, City Council authorized the refurbishment of the City's 2008 Pierce Impel 75' HD Ladder Truck. It has taken some time based on the industry to get the apparatus to the point of finally being ready for the refurbishment to begin. Pierce Manufacturing has started tear down of the City's ladder truck and during the tear down and inspection, additional defects have been found that were not able to be seen until the tear down phase. In order for the City to achieve its 3rd party UL aerial certification most of these repairs are required to be completed to put the ladder truck back into service.

In discussion with the City's fleet department, it has been determined that all the repairs listed are reasonable in pricing and needing to be completed. The department has opted to forego Line Items 3, 25 and 26, which are not required for aerial certification and are brake repairs, which the City's fleet department can do at a lesser cost upon return of the apparatus to the City. The department is requesting City Council's approval of these additional repairs and funding in order to complete the refurbishment of the ladder truck in order to get it back into City operations.
