SUBJECT: Snow Removal Services 2023-2024 Winter Season

REQUEST:

City Council is requested to authorize the issuance of a blanket purchase order to Ultra Professional Outdoor Services, LLC, 4565 Dixie Highway, Waterford, MI 48329 for snow removal services for the 2023-2024 winter season at the City Hall, 52/3rd District Court, Oakland County Sheriff's Office Substation, the five fire stations and two parking lots near the Brooklands Plaza in the amount not-to-exceed One Hundred Seventy Thousand (\$170,000) Dollars through June 30, 2024.

REASON FOR PURCHASE:

It is important to the City to provide a safe environment for persons accessing City buildings and properties during the winter months.

Last Year, City Council awarded the contract for Snow Removal Services at ten City locations including City Hall, 52/3 District Court, Oakland County Sheriff's Substation, the five fire stations and two parking lots near the Brooklands Plaza to Ultra Professional Outdoor Services, LLC. The vendor provided the best value and submitted the most responsive, responsible proposal for snow removal services for the 2022-2023 winter season. Ultra Professional Outdoor Services, LLC has performed the noted services in the past in a professional and satisfactory manner. The term awarded was one year with two one-year renewals.

The City of Rochester Hills wishes to exercise its first option to renew for the 2023-2024 winter season. The vendor has agreed to hold pricing and all the terms and conditions of the contract for the renewal

Snow removal services at remaining City facilities will be completed by City personnel. The City has the option at any time during the term of the contract to add or delete buildings and/or services.
