SUBJECT: Purchase Authorization for Four (4) Lucas Chest Compression Devices

REQUEST:

City Council is requested to authorize the purchase of four (4) Lucas 3 chest compression devices, required accessories, and preventative maintenance program to Stryker, Redmond, Washington in the amount of \$105,527.48.

REASON FOR PURCHASE:

The Rochester Hills Fire Department's seven ambulances are equipped with automatic chest compression devices along with a device located in the Battalion Chief's vehicle. These devices supply automatic chest compressions to adult patients suffering cardiac arrest in a pre-hospital situation. The Rochester Hills fire Department has standardized its cardiac equipment to Lucas, providing uniform operable chest compression devices through the City.

Stryker is the sole source provider of Lucas Equipment. As sole source provider, the City negotiated with Stryker to achieve a 15% discount off list price for the products, along with being provided a trade-in value for its older units. It is the city's opinion that the trade-in value provides more value than what would be obtained through the City's surplus auction process and recommends trading in the units.

** Please note:

If this purchase is approved, Stryker will offer a \$12,000 trade-in credit for City's the four (4) older units, which will reduce the net cost to the City for the replacement of four (4) Chest Compression Devices to \$93,527.48.

BUDGET:

Partial funding is included in the FY 2023 Adopted Budget.

If approved by City Council, a 2nd Quarter Budget Amendment will be presented to increase the expense to cover the purchase, which is offset by the trade-in value.
