# **REQUEST:**

City Council is requested to authorize a blanket purchase order to Detroit Salt Company LLC, Detroit, Michigan for the purchase of rock salt for the winter season 2008-2009 in the amount not-to-exceed \$182,545.00 through June 30, 2009.

# **REASON FOR PURCHASE:**

Sealed bids were solicited for sodium chloride (rock salt) by the Road Commission for Oakland County on behalf of the Michigan Intergovernmental Trade Network (MITN) in May, 2008. As a cooperative bid 241,250 tons of salt for 24 governmental entities, including the City of Rochester Hills, was bid.

The lowest responsive responsible bidder was Detroit Salt Company LLC at a bid price of \$33.19 per ton. Pricing is extended to all 24 participating communities. This year the cooperative communities' accounts are assigned to a primary contact for delivery and ordering issues.

It is recommended that the City award the rock salt contract to Detroit Salt Company LLC for 5500 tons at \$182,545 per ton. Quantities will be managed by the department to insure an adequate supply.
