In connection with the grant of easement, Grantor waives and relinquishes any right, title or interest in the sanitary sewer lead, or the facilities incidental thereto, which may be located in the easement.

All property disturbed or altered, now or in the future, by reason of the construction, operation, maintenance, repair and/or replacement of the sanitary sewer lead shall be restored by the Grantee to its immediately prior condition, except to the extent permanent improvements or alterations necessary to the use and exercise of easement rights granted hereunder are made.

The easement shall be irrevocable and non-exclusive, and Grantor and Grantor's successors and assigns may use and enjoy the easement area in common with the Grantee.

Grantor expressly reserves to Grantor and Grantor's successors and assigns, so long as there is no interference with the construction, operation, maintenance, repair and/or replacement of the sanitary sewer lead: (a) the right of ingress and egress over, through and across the easement, and (b) the right to grant other non-exclusive easements and rightsof-way, across, over, under and through the easement parcel, with the condition that prior to such a grant written consent shall be obtained from the Grantee.


