SUBJECT: Towable Wood Chipper

REQUEST:

City Council is requested to authorize the purchase of one (1) new Vermeer BC1500 towable wood chipper to Vermeer of Michigan, Jackson, MI in the amount of \$31,260.00.

REASON FOR PURCHASE:

Request for proposals were solicited for one (1) new towable wood chipper utilizing the MITN e-procurement system. Four responses were received. A committee made up of Forestry, Fleet and Purchasing staff evaluated the responses and equipment. As part of the proposal, vendors were required to provide demonstrations of the equipment they were proposing and allow the Forestry division to utilize the equipment in their operations for an afternoon. There were several criteria used to rate the machines functionality, some of which included ease of use, dust blowback, safety, and repairability. It is recommended that award be made to Vermeer of Michigan as their proposed machine, Vermeer BC1500, offers the best value to the City based on its performance, productivity, safety, cost, and ability to meet the City's specifications.

The towable wood chipper is utilized year-round by the Forestry department for the maintenance of the City's trees, and for removing downed trees, limbs and branches from roadways and right-of ways caused by ice storms, high winds, and heavy snowfall. The current Forestry towable wood chipper is fully depreciated and scheduled for replacement. The replacement of the towable wood chipper is provided for in the fleet replacement policy. The fleet replacement policy was created in 1988 to provide a responsible program and process for the practical maintenance and replacement of the City's vehicles and equipment. The replacement scheduled is based upon several factors, including maintenance and repair costs, reliability and productivity for its intended uses, and technical, safety, and operational advances that have occurred since the previous purchase.
