Over 5,000 gymnasts have participated in this meet over the years. These visitors come from all over the Midwest and stay in the local hotels and visit our many eateries and shops. The business community of Rochester and the surrounding community have been generous in their support of the CBC. The Classic Boosters Club supports our local businesses by purchasing their services and goods. The Club has also supported local food banks through canned food drives and collection of home goods and clothing for local charities.

The GTC competitive teams supported by the Classic Booster Club, Inc. travels nationally. The teams are passionate about gymnastics and exhibit the best qualities of competitive athletes and exhibit excellence in sportsmanship. The team is proud to represent the City of Rochester Hills throughout the country. Many individual team members have accomplished state championships, Region 5 championships and qualified for national competition within the USA Gymnastics competitions.

The Classic Booster Club, Inc., is making an application for a charitable gaming license that will allow us to conduct 50/50 raffles, small and large prize raffles at our gymnastic meets, team banquets and other fundraising events in compliance with the laws of the state of Michigan.

The Classic Booster Club thanks the Rochester Hills City Council for their kind consideration in granting this request to be recognized by the council through a resolution.
