TWO OPTIONS:

(Option 1)

Resolved that the Rochester Hills City Council hereby approves the placement of the Pathway Millage proposal on the November 7, 2006 State General Election ballot as follows:

BALLOT QUESTION

Pathway Millage

Shall the City of Rochester Hills levy a new millage of up to 0.1858 mill (\$0.1858 per \$1,000 of taxable value) on the taxable value of all property assessed for taxes in the City for a period of ten (10) years, beginning in 2006, and continuing through 2015, inclusive, to establish, construct, maintain and repair pathways and surfaces for use by bicycles, non-motorized vehicles and pedestrians along main, arterial and collector roads and on trailways and to create linkages to pathways, schools and destinations in the City? If approved, this millage will replace the previously authorized 0.2 mill pathway millage which has expired. The estimated amount of revenue that will be collected in the first full year if the millage is authorized and levied in full is \$669,200.00.

To replace the previously authorized 0.2 mill pathway millage which has expired, shall the City of Rochester Hills levy a new millage of up to 0.1858 mill (\$0.1858 per \$1,000 of taxable value) on the taxable value of all property assessed for taxes in the City for a period of ten (10) years, beginning in 2006, and continuing through 2015, inclusive, to establish, construct, maintain and repair pathways and surfaces for use by bicycles, non-motorized vehicles and pedestrians along main, arterial and collector roads and on trailways and to create linkages to pathways, schools and destinations in the City?
