Ms. Deanna Hilbert, 3234 Quail Ridge Circle, indicated that she had been in contact with the State's Attorney General's office and was advised that the City's public notices and resolutions for Council meeting in Closed Session do not meet State law and must be more specific as to the reasons for the Closed Session meetings.

Mr. Steve McGarry, 2164 Clinton View, addressed the REI project and the environmental risks associated with the development. He also noted that there are rumors in the community that REI is experiencing financial difficulties that may result in a "skinnied down version" of the remediation of the project site. He reminded Council that they are the community's "gatekeeper" with regard to this project.
