AN ORDINANCE TO AMEND SECTIONS 54-501 AND 54-502 IN CHAPTER 54, FEES, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY FEES CHARGED FOR ITINERANT MERCHANTS AND ICE CREAM VENDORS AND TO REPEAL CONFLICTING ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 54-501 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-501. Itinerant merchants.

The permit fees for itinerant merchants, per individual, as provided in section 78-164, shall be \$75.00. The annual license fee for ice cream vendors, as provided in section 78-171, shall be \$25.00, per vehicle.

<u>Section 2</u>. Section 54-502 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-502. Mobile food vending.

The license fees for mobile food vending units, as provided in section 78-212, shall be as follows:

- (1) Non-refundable application fee (per unit) \$100.00
- (2) Annual license fee (per unit) \$170.00
- (3) Annual license fee for ice cream vendors shall be \$25.00 per vehicle.

<u>Section 3</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

<u>Section 4</u>. <u>Penalty</u>. Except as otherwise provided therein, all violations of this ordinance shall be municipal civil infractions and upon a determination of responsibility therefore shall be punishable by a civil fine of \$500.

<u>Section 5</u>. <u>Repeal, Effective Date, Adoption</u>.
