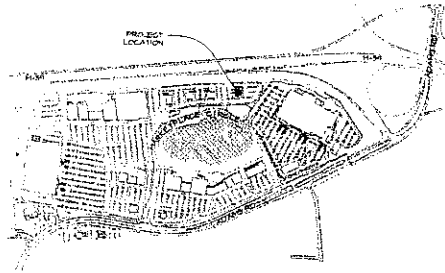

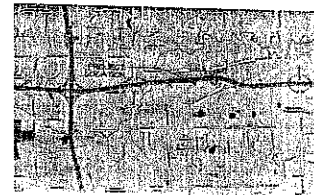

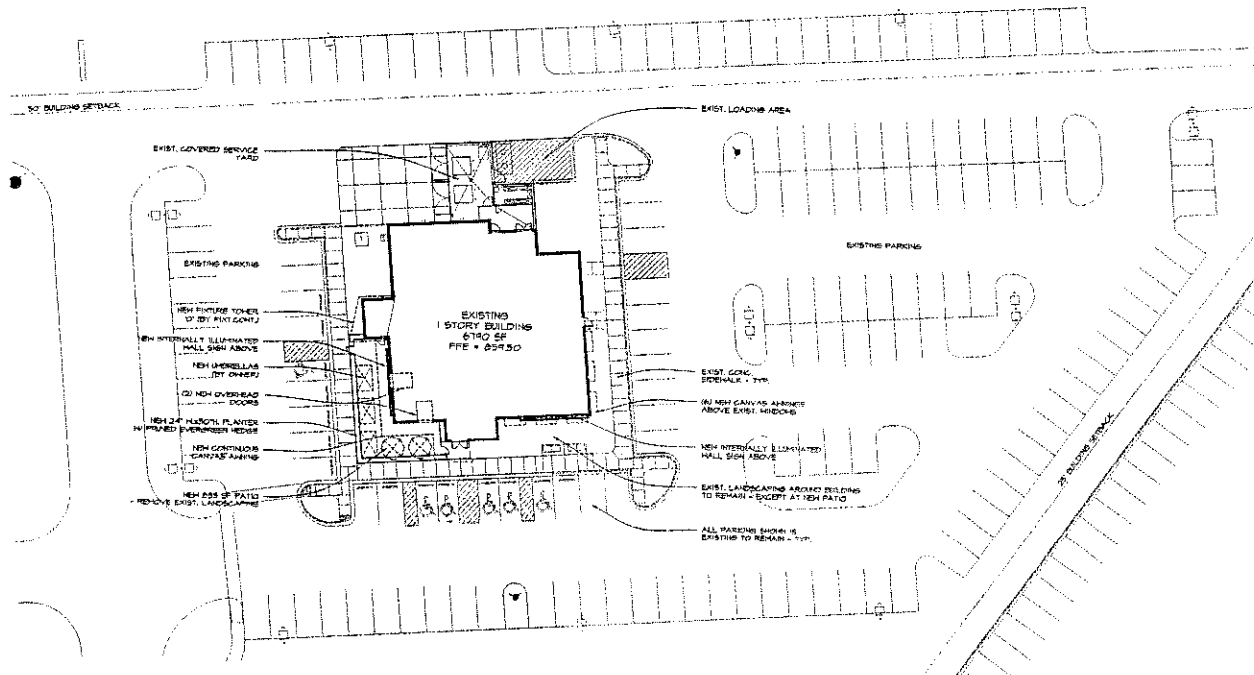




3 Site Key

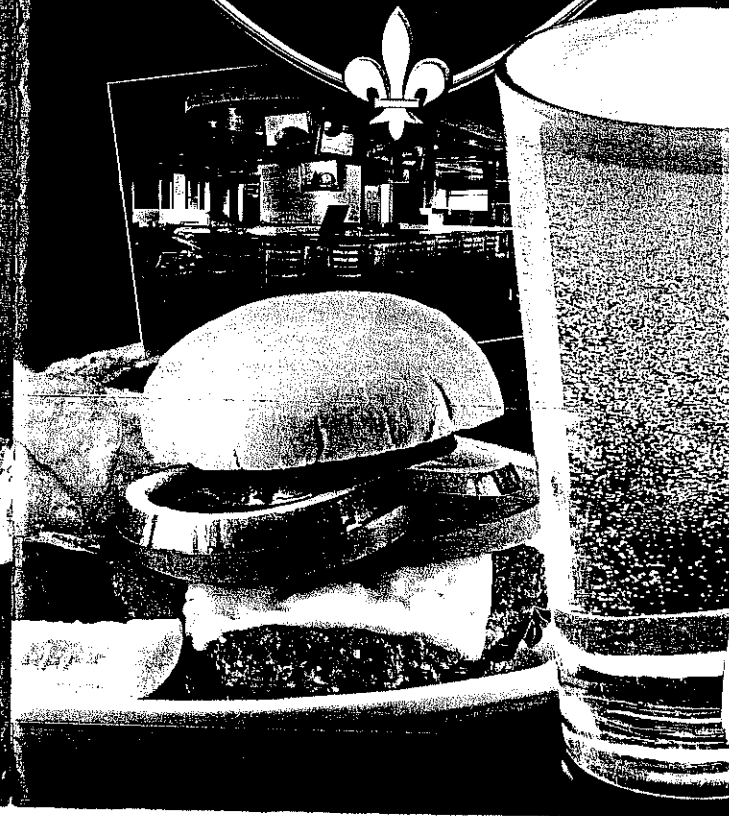

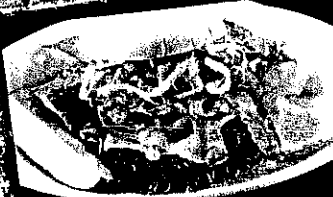
