SUBJECT: Overhead Door Replacements at Fire Station 1

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for the purchase and installation of overhead doors at Fire Station 1, 1111 Horizon Court, Rochester Hills to Secure Door, LLC, 75 Lafayette, Mt. Clemens, MI 48043, in the amount of \$125,282.00 with a 10% project contingency in the amount of \$12,528.20 for a total not-to-exceed project amount of \$137,810.20.

REASON FOR PURCHASE:

The overhead doors at Fire Station #1 have exceeded their life expectancy. The Facilities Department has had an increase in service call requests and the doors need to be replaced. Facilities is being proactive in infrastructure management and requesting these doors to be replaced. The new overhead doors will also match the overhead doors currently installed at all the other fire stations within the City.

The City issued Request for Proposals for the nine overhead doors at Fire Station 1 on the MITN system. Two competitive proposals were received and evaluated by a committee consisting of Facilities, Fire and Purchasing staff. The committee determined the proposal received from Secure Door, LLC was the best value to the City based on experience, comparable projects, and capacity and are recommending the award be made to Secure Door, LLC.

The overhead doors were originally scheduled in the 2023 Budget.
