## LEGISLATIVE & ADMINISTRATIVE COMMENTS

**Mr. Yalamanchi** questioned whether the City has a commercial property maintenance ordinance and, if so, he asked that it be enforced, noting that many properties are not being properly maintained. Noting the environmental issues brought to light by various developments in the City, he requested that the administration be proactive in pursuing assessment grants from the Environmental Protection Agency (EPA).

**Mr.** Ambrozaitis concurred with Mr. Yalamanchi's comments and requested an update of the residential blight ordinance. He referenced the previous day's election and the very limited school items on the ballot and expressed his hope that the school district would agree to include their issues on the City ballots in the fall in an effort to save tax dollars.

Ms. Holder announced that the City was recruiting applicants for the 2006-2007 Rochester Hills Government Youth Council (RHGYC) and urged interested parties to submit their applications by May 26th. She then described an upcoming fundraiser for the American Cancer Society on May 21st. She provided an update of Shelby Township's single waste hauler contract and the resulting savings to their residents. Finally, Ms. Holder expressed her continuing support for a strong mayor form of government for Rochester Hills contrary to a recent claim in a local newspaper.

Mayor Barnett thanked City Clerk Jane Leslie, her staff and the poll workers "for another flawless election." He noted that he and Mr. Ambrozaitis had attended an awards ceremony for Rochester Area Youth Assistance (RAYA) honoring local students for selfless acts. He announced that the Parks Department had received two Keep American Beautiful awards for 2006. He reminded Council of their football game played against the City of Rochester's City Council, and informed them that the vintage baseball team, The Grangers, had challenged both Councils to a game in the near future. He reminded residents of his "open office" hours each Thursday between 1:30 p.m. and 3:00 p.m. Finally, Mayor Barnett indicated he would be preparing a presentation regarding all of the "extremely positive things happening with our SmartZone" including the creation of over 600 jobs in 2006. With regard to Mr. Yalamanchi's requests, he noted that he would look into both of the matters and encouraged all Council members to spend time with the City's ordinance enforcement officers, referring to it as "a really eye opening experience."

Mr. Roger Rousse, Director of DPS/Engineering, explained that the request before Council was for the right-of-way acquisition for the first phase of a multi-phase project involving road and drain improvements, pathway construction, Spencer Park parking lot improvements and the relocation of the Michelson pump station. He noted that the right-of-way acquisition would likely take approximately nine months.

## **PUBLIC COMMENT**:

Ms. Melinda Hill, 1481 Mill Race, noting that she was not concerned with the cost of the project, but rather expressed her concern that this project was being identified as a carryover form the 2005 budget when it was not included as such in the 2006 budget. She stressed that it should have been clearly indicated by staff during the previous year's budget process that the project was delayed and funds should be earmarked for the following year.

**Mr. Rousse** explained that as late as October of 2005 the City administration believed the project would move forward in 2005. He noted that, as it is a "multi-leg" project, unexpected changes to the scope of the Michelson pump station portion resulted in an unanticipated delay.

**Mr. Duistermars** confirmed that a budget amendment reversing these funds had been passed by Council members, and, thus proper steps had been taken to account for these dollars.

Mr. Ambrozaitis called for greater transparency with regard to City funds.

It was stressed by **Mr. Duistermars** and **Ms. Holder** that nothing dishonest had occurred in this circumstance.

**Ms. Hill** stated that she had not intended to accuse anyone of doing something "underhanded." She did not approve of the budgeting process in this instance and asked that, in the future, these types of project delays be identified as carryovers in the budget.

**President Rosen**, returning to the issue of the project itself, noted that the City's Master Thoroughfare Plan (MTP) does not call for widening of John R Road at any point in the near future.

**Mr. Rousse** noted that the traffic and right-of-way warrants meet the criteria established in the MTP to expand John R to three lanes. He further noted that the MTP is nearly seven years old and traffic patterns and road improvements in neighboring communities such as Troy should also be taken into consideration.

**President Rosen** stressed the many thousands of dollars had been spent employing a consultant to assist with the formulation of the MTP and that the results of that study

cannot be overridden in an ad hoc manner. He noted that John R, in effect, is a dead end road and it would be preferable to concentrate the City's efforts and dollars on Dequindre Road, "because it actually allows people to go someplace."

**Mr. Rousse** noted the improved safety that would result from this project and also stressed the savings associated with combining various projects such as the pathways construction and relocation of the pump station. He also indicated that this entire project would save in "mobilization fees."

**Mr. Duistermars** indicated that the MTP is not "etched in stone", noting that it would be prudent to reassess the City's priorities.

**President Rosen** stressed that he does not oppose the right-of-way acquisition, but rather, "the fundamental question of not following through with the planning process." He expressed his disapproval of "deciding to go to three lanes without going through the Planning Commission, the transportation planning process and, frankly, not much in the way of public hearing."

A motion was made by Raschke, seconded by Duistermars, that this matter be Adopted by Resolution.

Resolved that the Rochester Hills City Council approves the proposal between Hubbell, Roth & Clark, Inc. and the City of Rochester Hills for Right-of-Way Acquisition Services for the John R Road Widening and East Ferry Drain Improvements in the amount not-to-exceed \$166,515.00, and authorizes the Mayor and Clerk to execute a contract on behalf of the City.

Mr. Roger Rousse, Director of DPS/Engineering, explained that this request represented the first phase in a multi-phase project. He indicated that this project would include the new five-lane bridge striped for three lanes, a traffic signal at Kings Cove and Oakbrook, and pathway improvements. At President Rosen's request, he listed some of the recommendations from the Tienken Road Corridor study:

- Conversion of the intersection at Tienken Road and Rochester Road to a six-lane boulevard.
- Improvements to the Sheldon intersection.
- Bridge replacement.
- A traffic signal at Kings Cove.
- Widening of the entire road.

**Mr. Rousse** noted that the Tienken Road improvements are listed in the Capital Improvement Plan (CIP), representing a multi-phase project with phased-in improvements at various locations along the corridor.

**President Rosen** noted that the Tienken Road Corridor Study was never reviewed or approved by the Planning Commission as a revision to the Master Thoroughfare Plan. He stated, "You can't go around the transportation plan." He noted that the plan for a five-lane bridge was never reviewed with the community and noted, "The most we're ever going to get out of that road is three lanes without completely destroying that entire corridor."

**Mr. Rousse** stressed that each step of the project will be brought forward to the Planning Commission and City Council for approval. He further noted that some improvements have already taken place, specifically noting the intersection improvements at Tienken Road and Rochester Road funded by private developers.

**Mr.** Ambrozaitis noted his opposition to widening Tienken Road to five lanes and indicated that there should be a public hearing on this matter to receive comments from residents, especially those who will be directly impacted.

**Ms. Holder** made a motion to postpone the decision on this item until more detailed information can be provided to Council.

A motion was made by Holder, seconded by Duistermars, that this matter be Postponed by Resolution.

Whereas, there are several funding sources proposed to fund the Tienken Road Bridge Replacement and Traffic Signal Project that include Tri-Party funds, federally appropriated Michigan transportation funds, RCOC construction engineering and City major road funds; and

Whereas, the proposed Cost Participation Agreement is a mechanism to program the Tri-Party funds through the Board of Road Commissioners for the County of Oakland (BOARD); and

Whereas, upon execution of this Agreement, the BOARD shall submit an invoice to the City in the amount of \$590,810.50, which is 50% of the City's share; and

Whereas, the BOARD may invoice the City periodically as additional costs accrue, after the initial payment has been expended; and

Whereas, upon completion of the project construction, the BOARD shall submit an estimated final invoice to the City for the remainder of the City's share of the total estimated final project cost.

Resolved that the Rochester Hills City Council hereby postpones approval of all conditions of the Cost Participation Agreement between the Road Commission for Oakland County and the City of Rochester Hills for the Tienken Road Bridge Replacement over Paint Creek and the Traffic Signal Installation until Council members have thoroughly reviewed all previous studies relating to this project, as well as the current Master Thoroughfare Plan, and a work session is held to review and discuss this project in detail.

#### **DISCUSSION CONTINUED**

City Attorney John Staran advised Council that the discussion could continue in an effort to ascertain what information Council required to make a final decision.

## **PUBLIC COMMENT**:

Ms. Melinda Hill, 1481 Mill Race, expressed her opposition to a five-lane bridge noting that not even the Tienken Road Corridor Study recommended five lanes. She stated it would be "irresponsible spending" to widen Tienken Road to five lanes as it would also increase the costs to maintain the road. She called for a reevaluation of the City's Master Thoroughfare Plan, as well as public hearings on the matter.

**Mr. Duistermars** indicated that the previous Council was aware that the new bridge would be engineered for five lanes and stressed that the City would incur additional design costs if it were necessary to redesign the bridge for three lanes.

**Mr. Rousse** discussed the various issues that led to the design of a five-lane bridge, including the following:

- The five lanes left open the option of Tienken Road becoming a boulevard.
- The center lane accommodates "turning movements" at the intersection.
- The City could still maintain a boulevard with one bridge rather than two bridges side-byside.
- The project was discussed each year as part of the CIP process.
- The project was reviewed in light of the Tienken Road Corridor Study as well as other traffic improvements in the area.

- Tienken is a County road and, thus, the City is participating in this project as part of a Tri-Party Fund Agreement.
- There is an accident history in that area.
- Residents spend an excessive amount of time trying to make left turns out of the Kings Cove subdivision.
- The bridge had to be widened to provide stacking lanes for a new traffic signal.

**Mr. Duistermars** confirmed that the reasoning behind the five-lane bridge was to provide more versatility in the future.

**Ms. Holder** indicated that if the Tienken Road barricade in Auburn Hills is eventually removed, it will result in a considerable increase in traffic on Tienken Road.

**President Rosen** listed information that should be provided to Council prior to the future meeting at which this matter would be discussed again:

- The Tienken Road Corridor study.
- The Master Thoroughfare Plan update from December 1999.
- Minutes from any public discussion, especially those linking the Tienken Road Corridor Study to the Tienken Road/Rochester Road intersection improvements.
- Minutes regarding the two PUD agreements that resulted in the Tienken Road/Rochester Road intersection improvements.
- Information on the warrants for a traffic signal at Kings Cove.

Mayor Barnett suggested that a Work Session be held near the end of the month and noted that all relevant information would be provided to Council members prior to that meeting.

**Mr. Roger Rousse**, Director of DPS/Engineering, explained that this request represented routine improvements to some City-owned buildings, particularly the roofs, in an effort to preserve the City's investment in these buildings and avoid further damage.

**Mr. Ambrozaitis** requested reassurance that the DPS salt storage barn roof would be repaired regardless of whether the new DPS Facility was built or not.

**Ms. Holder** made the observation that as the City's contracted architectural and construction management firms had already provided plans for the reconstruction of a new salt storage barn, prior to the plan to reevaluate the scope of the DPS Facility project, the cost of those plans should be included with the cost of repairing the roof of the existing salt storage barn.

# **COUNCIL COMMITTEE REPORTS**

## **Leisure Activities Committee**

**Mr. Ambrozaitis**, Chair of the Leisure Activities Committee, noted that Mike Hartner, Director of Parks & Forestry, had provided the Committee with a presentation regarding the update to the Parks & Recreation Master Plan. He also requested that the City spend \$5,000 to test the Riverbend Park water table.

## **Planning Commission**

**Ms. Holder**, City Council representative to the Planning Commission, briefly noted that they had unanimously approved a revised preliminary site condominium plan for a development south of Auburn Road and east of Livernois Road. She also announced that a Public Hearing would be held for the proposed Capital Improvement Plan on May 16th at 7:30 p.m.

# **ANY OTHER BUSINESS**

Mr. Yalamanchi requested a process be put in place wherein ongoing issues, such as local roads and the City's tax structure, be noted if not addressed or discussed at each Council meeting. He expressed concern that Council may lose focus on these pressing items if they are not part of the agenda for each meeting. Second, Mr. Yalamanchi questioned whether

the City has any relationship with the local school district, similar to the Sister City committees for Rochester and Auburn Hills. He suggested that the City work to establish better communication with the schools but not necessarily in a formal manner, such as a committee.

**President Rosen** noted that he is working in conjunction with the Clerk's Department to establish a list of ongoing issues that can be distributed to Council members separate from their meeting agendas.

**Mayor Barnett** explained that he sits on many committees with school representatives and is working to build better communication with the new superintendent. He indicated that he would support Council involvement in this process.

President Rosen briefly described the process by which applicants to fill Mayor Barnett's vacant Council seat would be interviewed during the May 4th Special Council meeting. He noted that Council members will be given the opportunity to ask each applicant one or two questions. Following their responses, Council will make their nominations. Voting will follow the nominations and will continue until a new Council member is chosen or until the hour grows too late and it becomes necessary to adjourn the meeting and hold another Special Meeting on Saturday, May 6th to continue the voting process. He further explained that, during the initial interview process, the applicants will be seated at the Council dais, while the six Council members will be seated at the presenters table.
