Attached please find a copy of the Bolinger Street paving petition objections, objection petition verification report and a map indicating those parcels that have signed the objection petitions.

From the Bolinger Street total gross lineal front footage within the proposed district, 1,351.00 feet, we have verified signatures of owners of record on 571.00 lineal front feet. This calculates to 42.26% of the property fronting the street to be paved. Of the 13 property descriptions that comprise the district, 6 (46.15%) have objection petition signatures.

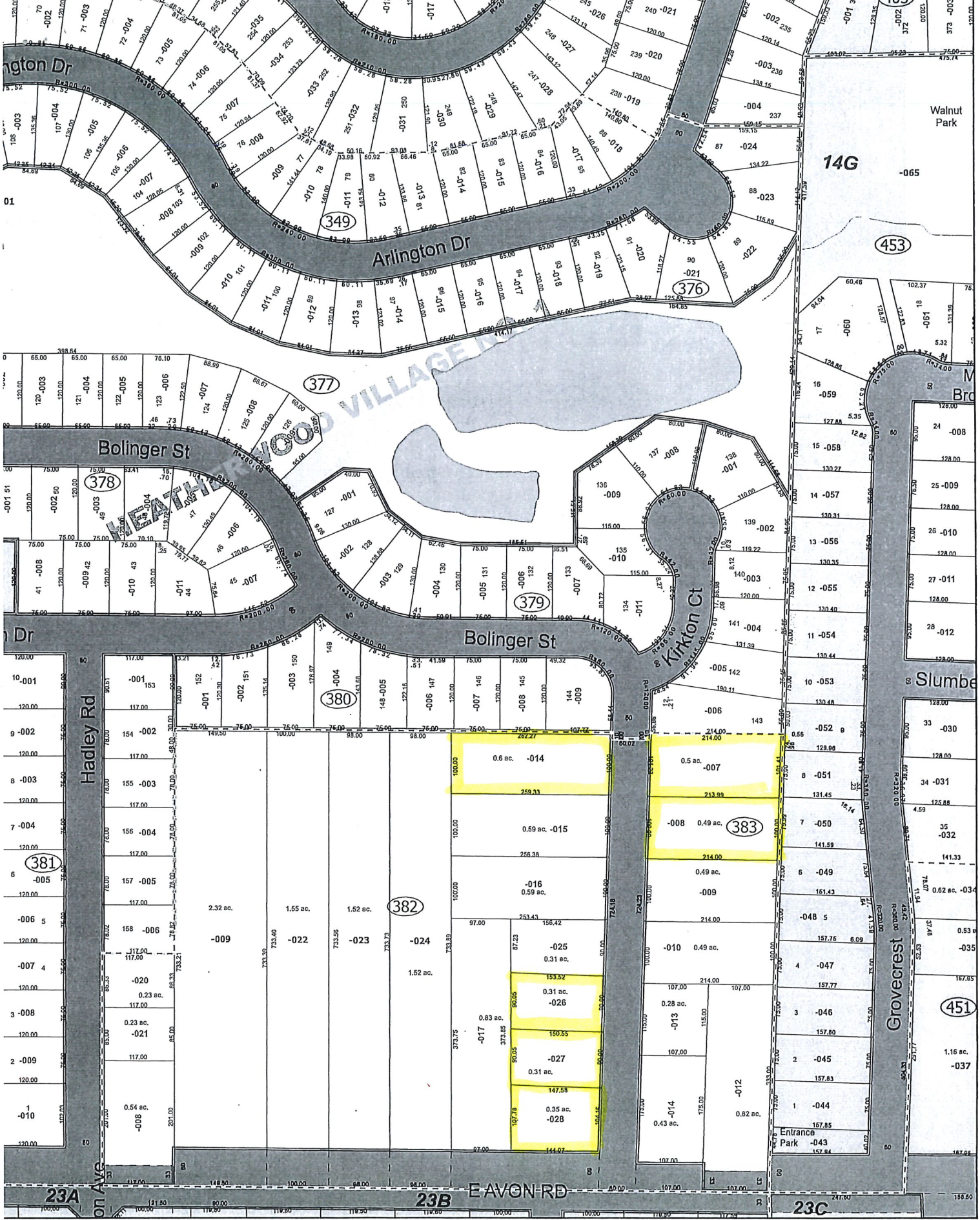
