SUBJECT: Playground Equipment Purchase

REQUEST:

City Council authorization for a blanket purchase order to Michigan Playgrounds, Inc. of Holland, Michigan to supply and install playground equipment and safety surfacing in Avondale and Spencer Parks for a not to exceed amount of \$45,000.

REASON FOR PURCHASE:

The playground project replaces and upgrades equipment at Spencer and Avondale Parks. The current equipment is worn from use and age and has raised safety and compliance concerns with both the Consumer's Product Safety Commission's (CPSC) guidelines and American Society for Testing and Materials (ASTM) standards for public playgrounds. We will also be able to upgrade the play features using new elements that will make the play areas more exciting and challenging.

PROCESS:

A Capital Improvement Project (CIP) was developed to replace and upgrade playgrounds within the City's parks. The project is identified as PK-17A, Playground Upgrades and was expected to take several years to accomplish. The intent was to work with a single company for the entire project to standardize the City's playground equipment and to minimize the parts inventory necessary for maintenance. The City used a Request for Proposal to select a company that could provide a wide range of services including design and installation as well as a strong knowledge of the CPSC and ASTM requirements, both of which have been adopted as law in the State of Michigan. A group consisting of City staff, community schools staff and private citizens reviewed the proposals and selected Michigan Playgrounds, Inc. for the project. Michigan Playgrounds has installed seven playgrounds for the City to date.

Equipment costs are scheduled to increase after January 27, 2006. By ordering before that date we can get 2005 pricing. The equipment will not be delivered and installed until spring.
