## **Gerald G. Carvey Candidate Questionnaire**

**Item. Interest/Reasons/Qualifications.** I have always had a deep interest in nature and the out-of-doors. For example when I was on City Council I was the lone voice for saving the green space surrounding City Hall. Twice efforts were made to place other facilities on the property. I was able to convince Council to protect it and now we have the Environmental Center making great use of property. I joined and worked with the other council members and city staff to develop and sell the bond issue which purchased many of our present day park lands.

I was asked to be a part of the group that developed the City's Strategic Plan back in 1998 & 1999. At the conclusion of the plan, Dr. Gary Russi, the chairperson for the Planning process asked who would like to join in the implementation of portions of the plan. I volunteered to chair the Land Preservation Committee. With a great committee which included many different stakeholders, and a lot of hard work we developed "The Clinton River in Rochester and Rochester Hills: A Greenways Opportunity Plan".

The plan was presented to the City Councils of both Rochester & Rochester Hills and to both communities Planning Commissions. The plan is on file at the City and contains a lot of great information about the river –trail corridor that runs through both communities.

Out of this plan came the idea to present a millage, for land preservation, to the citizens of Rochester Hills. Our first effort, which I chaired, was narrowly defeated. However, we believed we had learned a great deal and so presented a lower millage rate and doubled our efforts to get it approved.

As you can see I have been in this effort to save green space from the beginning and now would very much like to be a part of it as we look at ways to maximize the millage funds with grants and other innovative ways to preserve green space.

**Item. Other Organizations.** Member and served as volunteer Financial Manager for Clinton River Watershed Council for 15 years, member Greater Rochester Community Foundation, member Oakland Land Conservancy, spent many years working on the Rochester Community Christmas Parade and served as chairperson 3 different times.
