## **PUBLIC COMMENT**

**Ms. Lori Crose**, 550 Lockport Road, representing Oakland University, announced the "Second Annual Emergency Preparedness for Business Continuity Conference" to be held on November 10th. She indicated that the conference is intended to inform businesses about emergency response plans to promote personal safety and business preservation.

**Ms. Beth Tilove**, 769 Snowmass Drive, listed various efforts on the part of the Residential Streets Ad Hoc Committee to inform residents about the road millage proposal on the upcoming November Ballot:

- \* Informational program in conjunction with the League of Women Voters to air on Channel 55.
  - \* Informational mailing to all residents.
- \* OPC candidates luncheon.
- \* Town hall meetings.
- \* Meeting with the Detroit News Editorial Board.

**Mr. Barnett** clarified that all of these efforts were being coordinated by the citizen's ad hoc committee, not City staff nor elected officials.

Ms. Brenda Mueller, 2649 Winter Park Road, announced the formation of an advocacy group called Citizens for Better Streets in support of the road millage.

Ms. Kathy Bommarito, 898 Augusta Drive and Ms. Joanne Marcil, 547 Augusta Drive, announced that their Brookwood subdivision would be holding their seventh annual flea market on October 22nd to benefit "Make a Difference Day," which they described as "the largest community service effort in the nation rallying charitable organizations and citizens into action on one day."

Ms. Debbie Geen, 3128 Walton Boulevard, Chairperson of the Residential Vision Committee, questioned Council's spending on certain budget items in lieu of plowing roads and criticized the size of the road millage proposal. She urged Council to contact a consultant who she claimed would provide a presentation free of charge to assist the City with its financial issues.

**President Hill** noted that the road millage request is actually smaller than in previous years and that her request to Ms. Geen to provide more information about the financial consultant has yet to be fulfilled.

**President Hill** indicated that Council had passed a resolution requiring that a committee be created following the passage of the open space millage to act in an advisory capacity and bring recommendations forward to Council for the acquisition of open space. She noted that the Community Development & Viability (CDV) Committee and the Leisure Activities Committee had preliminary discussions to determine the composition of the new committee.

*Mr. Barnett*, Chairperson of the CDV Committee, explained that the committees had made the following determinations:

- \* The new committee would have no authority, but would serve solely in an advisory capacity.
- \* Membership would consist of seven (7) voting citizen representatives, four (4) non-voting ex officio members (City Assessor or his/her designee, the City Parks/Forestry Director or his/her designee, the City Surveyor or his/her designee and one City Council member).
- \* The mission of the committee will be to develop strategies and recommendations to City Council regarding the expenditure of millage funds for permanently preserving natural green spaces, wildlife habitats and scenic views; protecting woodlands, wetlands, rivers and streams; and expanding the Clinton River Greenway and other trail corridors.

Mr. Barnett noted that the objective of the committee is broad and asked for input from his fellow Council members.

**Mr. Robbins** questioned the need for this new committee, stating that the Leisure Activities Committee could fulfill this purpose without "further enlarging the bureaucracy." He further noted that there will be a cost associated with supporting this new committee and questioned how these costs will be met, as the millage funds cannot be used for this purpose.

Mr. Staran concurred that it was unlikely millage dollars could be used to support the advisory committee.

**Minutes** 

**Mr. Duistermars**, Chairperson of the Leisure Activities Committee and member of the CDV Committee, noted that one of the main topics discussed was the restriction of membership. He stated that it had been determined that no paid officials or paid directors of organizations or groups whose responsibilities deal with land conservation or trail systems be appointed.

Council members agreed that potential applicants will need to be evaluated in terms of their affiliations to ensure that there is a cross-section of representation on the committee.

**President Hill** encouraged Council to think about the process further and come forward on October 19th with recommendations for the process of not only appointing members to this committee, but also the process by which the committee will bring recommendations forward to Council. For example, she questioned whether recommendations should be filtered through the communication committees, or whether a public hearing would a needed.

**Mr. Barnett** stressed the importance of establishing all the criteria before requesting applications from interested parties.
