SUBJECT: Window Cleaning Services

REQUEST:

City Council is requested to authorize a blanket purchase order / contract to Transparent Window Cleaning, 3601 Joslyn Road, Auburn Hills, MI 48326 for window cleaning services for several City building in the amount not-to-exceed Twenty-nine Thousand Seven Hundred Ninety (\$29,790) Dollars through December 31, 2026.

REASON FOR PURCHASE:

The City of Rochester Hills owns several buildings throughout the City that require routine maintenance and upkeep including window cleaning services.

The Purchasing Division solicited a request for quotations for window cleaning services. Historically the costs for these services are below the threshold for a sealed bid; however due to additional interior services at OCSO along with rising costs, the three-year total cost exceeds \$25,000 and requires City Council approval. Of the three quotes received, Transparent Window Cleaning submitted the low, responsive quote for the three-year term to clean the windows at City Hall, Department of Public Services Garage, Fire Station 1, Museum at Van Hoosen Farm and Oakland County Sheriff's Office Substation.

Transparent Window Cleaning has performed these noted services in the past in a professional and satisfactory manner.
