OPTION 1 - RECOMMEND EQUITY ADJUSTMENTS

OPTION 3 - RECOMMEND TO DEFER

Now, Therefore, Be It Resolved that the Administration and Information Services Committee requests City Council waive Article III, Salaries for Department Directors, Sections 5, 6, and 7 of the *City Council Policy for Salaries of Department Directors and Mayor and Per Diem Fees for Boards and Commissions* and defer setting the 2006 Equity Adjustment Pool until such time a recommendation is received from the Administration and Information Services Committee.

Be It Further Resolved that the AIS Committee shall make a recommendation to City Council prior to the final approval of the 2006 budget.
