SUBJECT: Park Conceptual Plans

REQUEST:

City Council is requested to authorize a contract/blanket purchase order for the development of park conceptual plans based on the proposed Park Master Plan Project that will be focused on (1) Bloomer Park, (2) Brooklands Splash Pad Grass Park, (3) Nowicki Park, and (4) Spencer Park in the amount not-to-exceed \$229,450.00 to Niagara Murano, Rochester, Michigan and further authorizes the Mayor to execute the agreement on behalf of the City.

REASON FOR PURCHASE:

Niagara Murano is one of the City's selected on-call professional architectural firms and was selected to perform this work with the City based on previous experience they have with the development of conceptual plans for various types of outdoor, park conceptual projects and their capacity to handle the work in the timeframe requested.

This plan will not only include significant public input on desired amenities, but will include visions for each park, topographical reviews for design issues, pedestrian traffic considerations, and cost estimates of various amenities and designs. Timeline of the study is targeted to be ready for final review of City Council in early 2024, in time for consideration of the next CIP process.
