SUBJECT: Contract for Telecommunication Services

REQUEST:

City Council is requested to authorize the issuance of a blanket purchase order to Wide Open West, Inc. (WOW) of Madison Heights, Michigan for the City's Telecommunication Services including Voice, Data, and CATV for one year in the amount of \$70,000.00 Dollars.

REASON FOR PURCHASE:

WOW Business, Inc. provides Telecommunication Services for the City. The Purchasing Division solicited utilizing the MITN System for competitively sealed proposals, which were opened on July 14, 2021. WOW Business, Inc. was selected as providing the best value and submitting the most responsive, responsible proposal for the services to the City. WOW Business, Inc. has performed the noted services in a professional and satisfactory manner for the past eight years.

The solicitation specified a base term of (3) years with two (2) one-year options to renew. The City of Rochester Hills wishes to exercise the first renewal option with WOW Business, Inc. of Taylor, Michigan, who has agreed to hold the pricing for the one-year term.
