Work Plan	Will furnish necessary equipment w/ trained operators to perform cleaning of catch basins. Catch basins will be scoured clean & vacuumed in their entirety removing all foreign debris that can be extracted through 8" vacuum inlet. Water generated from cleaning will be decanted back into downstream storm sewer, if necessary sanitary sewer used. Water at no cost from hydrants. When debris body full, debris will be brought to DPS/Garage & dumped into roll off box until full. Will stage 2 roll off boxes at DPS/Garage. Once two roll off boxes are full, Terra will haul boxes to Woodland Meadows for disposal.	Meeting with RH for requirements & scheduling of project; mobilize catch basin cleaning crew, traffic control put into place & each catch basin will be vacuumed clean; will inspect each basin and prepare inspection report including location of catch basin, depth of debris, condition of catch basin & note defects, repairs, blockages; debris transported for disposal to Type II Land-fill or licensed liquid industrial waste facility-temporary storage in roll-off; disposal per DEQ; City to receive documentation. Each unit cleans 30-45 basins per day pending structure conditions & current road weight laws. Units are equipped w/ load limit alarms to confirm that units do not exceed local weight restrictions. A 4000 gallon specialized dewatering truck will work immediately in front of the vactor units to remove liquids in the structure prior to vacuuming debris.
