REQUEST:

The Department of Public Services recommends awarding the contract for the *Christian Hills West Water Main Replacement & Road Resurfacing Project* to Bidigare Contractors, Inc. of Northville, Michigan in the amount of \$4,759,854.00 and authorizes the Mayor to execute a contract on behalf of the City.

The Department of Public Services also requests City Council authorization of a 10% contingency in the amount of \$475,985.40 to allow for quantity adjustments based final measurements verified in the field for a total not-to-exceed construction cost of \$5,235,839.40.

REASON FOR PURCHASE:

The Christian Hills West Subdivision project consists of a water main replacement project and an asphalt overlay project.

The water main replacement project is being completed because of its age, cast iron pipe material type and break history. The Scope of Work includes the replacement of approximately 27,000 LFT of 6" and 8" cast iron water main with 10" HDPE SDR 11 pipe via the pipe bursting method. The contractor will be responsible for supplying customers with a potable source of water or ensure that water shut offs are minimal during the main replacement project.

The scope of work for the road project includes a 2-inch mill and asphalt overlay project throughout the paved portions of the Christian Hills West subdivision. Also, upgrade pathway ramps, as needed, to meet ADA compliance. The contractor shall maintain local traffic at all times.

Rochester Hills received **five (5)** sealed bids for the project on March 3, 2015 (bid summary attached). Of the bids received, Bidigare Contractors Inc. was the lowest, responsive, responsible bidder.

Work is expected to begin in April 2015 with a completion date scheduled for November, 2015.
