REQUEST:

It is requested that City Council authorize an increase to the blanket purchase order/contract to the construction engineering (CE) services agreement for the Pedestrian Crossing/HAWK Signal at Adams Road and Marketplace Circle in the amount of \$14,100.00 for a new total not-to-exceed contract amount of \$61,000.00 to OHM Advisors, Auburn Hills, Michigan and further authorizes the Procurement Manager to execute the agreement on behalf of the City.

REASON FOR PURCHASE:

As part of the City's On-Call Professional Engineering Services agreement, the City requested a proposal from OHM Advisors, one of our selected firms, to provide a proposal to perform construction engineering services for the Adams pedestrian crossing project and subsequently entered into an agreement on September 12, 2023 to perform the required services. As the project has progressed to field installation, it's been discovered that revisions to the plans are needed in order to meet required ADA and grading requirements, as well as changes that have been requested by the Friends of the Clinton River Trail.

The City is recommending that OHM advisors provide the additional construction engineering services to incorporate the required changes into plan documents. The attached proposal describes the scope of services included for the construction engineering services to complete the work.
