CALL TO ORDER

President Hooper called the Regular Rochester Hills City Council Meeting to order at 7:01 p.m. Michigan Time.

APPROVAL OF AGENDA

A motion was made by Webber, seconded by Kochenderfer, that the Agenda be Approved as Presented. The motion carried by the following vote:

Mayor Barnett reported that a tornado touched down in Rochester Hills at 5:57 a.m. on Sunday morning. He stated that this was the first time in recent memory that a tornado has hit an area of the city, and he displayed photographs of the area affected in North Fairview Farms Subdivision. He explained that the tornado was on the ground for two minutes, lifting at 5:59 a.m.; and significantly damaged more than 30 homes on mainly three streets. He noted that six remain unsafe for occupancy, and some may be total losses.

He stated that City response teams were joined by the Salvation Army, who mobilized an evacuation center at Van Hoosen Middle School, and provided a food and water station, blankets and refreshments to residents and responders. He noted that at the height of activity nearly 100 people were on the ground providing aid. The impressive response was led by Oakland County Homeland Security, with Fire Chief Sean Canto as incident commander.

Mayor Barnett noted that the Category EF-1 tornado, with 90 mile per hour winds, did not register with the National Weather Service, and Oakland County was not contacted in advance to warn of its approach. He commented that the residents were outstanding, and news crews from Channels 2, 4 and 7 were helpful. He stated that while there was significant damage to structures and property, there were no injuries. He commented that there was a tremendous team spirit, with everyone looking out for each other.

He invited **Chief Canto**, **Scott Cope**, Director of Building and Ordinance Compliance, and **Allan Schneck**, Director of DPS/Engineering, to comment and detail activities.

Sean Canto, Chief of Fire and Emergency Services, explained that the Department received the first call at 6:35 a.m., which came in as a tree had blown over in someone's yard. Subsequently, information was transmitted that the front of a home was gone. He noted that once arriving on scene, responders saw that there was significant damage on Grandview, Fairfield and adjacent streets. He stated that 46 homes were impacted in some way, with 37 affected and seven receiving major damage. He reported that three homes remain unoccupied, tagged by the Building Department. Electric meters and gas services were ripped from homes, and priority was given to addressing trees which were hanging as the forecast was for additional winds later in the day. He introduced **Fire Lieutenant Jason Murray** and **Fire Captain Gerald Yurgo**.

Lieutenant Murray stated that he was the Chief Operations Officer yesterday, and explained that only one call was received reporting that a roof was blown off. He noted that Engine 4 arrived on-scene at 6:44 a.m. and Chief Canto arrived

at 6:46 a.m., where it was determined that either straight line winds or a possible tornado occurred, causing significant damage. Mutual aid was initiated, with City of Rochester, Oakland Township, Auburn Hills and additional Rochester Hills units activated. An initial survey done in the first 90 minutes yielded no reported injuries. Bob White, Supervisor of Ordinance Services, was on-scene. A county-wide communication system was initiated, Oakland County Homeland Security notified, a temporary evacuation site set up at Van Hoosen Middle School, and constant communication was kept with the neighborhood association. He pointed out that DTE Energy and Consumers Energy had critical roles. He mentioned that concerns over possible bad weather later in the day led to activation of the Oakland County Incident Management Team, and a command pod was brought out to coordinate activities of all agencies. DPS and Building Department staff members arrived on site. He commented that damage was not limited to that specific area; in fact, damage was reported as far away as Peach Tree off of Orion Road.

Fire Captain Yurgo noted that he was Battalion Chief for operations, and he arrived on-scene at 8:30 a.m. He explained that he took over as Incident Commander at 1 p.m. while Chief Canto was off-site. He stated that teams were established to survey and focus more on specific homes which appeared to be damaged the worst, to determine which homes were structurally sound enough to be reoccupied. He noted that the goal by the end of these operations was to have every home secured and reoccupied, if deemed safe. Initially, 1,000 people were out of power; by the end of operations last night, the only houses still without power were the unoccupied ones. He mentioned that Building, Forestry and DPS staff were involved; and he noted that Channel 7 provided their helicopter to Homeland Security and the Mayor to survey the area. He added that the Royal Park Hotel provided their shuttle, the Salvation Army mobilized, and the Rochester Schools staff opened two different school buildings for the residents.

Lieutenant Murray added that the Oakland County Sheriff's Department established a perimeter for security; and he commented that scrappers tried to enter. Companies providing board-up services attempted to gain entry to the area, and a secure way in and out of the perimeter was established to ensure that only those companies authorized by insurance companies were allowed to enter the area.

Mayor Barnett displayed photographs of neighborhood damage along with the mobile unit brought on site. He noted that a single point of communication was established between all parties and the media. He commented that the events and actions speak to the level of preparedness of the emergency responders, noting that around 50 City employees arrived on a Sunday morning to assist. He mentioned that the neighboring communities of Troy, Auburn Hills and Rochester will be coming in with chipper units to help clear debris, Republic Services will be assisting by providing dumpsters, and the City's Building Department will waive building permit fees for those affected. He commented that it was a Sunday morning miracle that no one was hurt, and he expressed his extreme thanks and appreciation to everyone.

Mr. Cope expressed his thanks to his eight staff members that came in to help, noting that it is a combined effort from all City departments.

Mr. Schneck concurred, noting that his staff members questioned how they could help. He stated that communications were seamless, residents were phenomenal, and agencies cooperated with each other.

President Hooper commented that this speaks to the excellent staff the City has, and he complimented Chief Canto's leadership.

Mr. Kochenderfer stated that he was on scene as well, and noted that he observed residents helping their neighbors. He commented that this speaks to Rochester Hills as a community. He expressed his thanks to all responders.

Mr. Webber commented that he knows many who live in the area and was able to visit the scene at 10:00 a.m. He noted that he heard questions as to why no tornado sirens were activated.

Chief Canto responded that he spoke with Oakland County Homeland Security, who reported that they had been in conference with the National Weather Service regarding the lack of notification. This event can be categorized as an isolated incident as there were no active thunderstorm warnings. He explained that approximately 50 percent or less of EF-1 tornados are actually caught by radar, as they happen quickly and are often masked by the weather itself. He noted that Homeland Security only activates sirens if the National Weather Services calls for them; and he pointed out that weather warnings were lifted at 4:30 a.m.

Mr. Wiggins expressed his appreciation to the Fire Department and Rochester Hills employees, noting that while this type of event has never happened before in the City, the process was implemented without a hitch.

PUBLIC COMMENT

Ann Edwards, 296 Meadowbridge, announced that the League of Women Voters will host a Candidates' Forum for State Representative 45th District on Tuesday, September 30th, 7:00 p.m., in the City Hall Auditorium. She mentioned that the League is preparing a voters' guide for the election, which will be available at City Hall, other local municipal offices, the Older Persons Commission and the Rochester Hills Public Library by October 9th.

Clifford Johnson, 3542 Charlwood Drive, commented that he has been encouraged by movements at the City lately and he stressed that Council continue considering the wisdom of opposing oil and gas extraction in residential areas. He mentioned that one public speaker at previous meetings accused those resisting the idea of oil and gas exploration as being guilty of "Not in My Backyard-ism" ("NIMBY"); and he stated that he can provide many examples where a world without "NIMBY" can lead to poor development.

Izzy Khapoya, 729 McGill Drive, stated that the City signed an oil lease without a vote. She mentioned an article appearing in the local newspaper about activities in the City of Rochester leading to Jordan Oil withdrawing its offer of a lease

there, and in Auburn Hills where special meetings were held to solicit public comment. She stated that the City of Rochester is contemplating an ordinance requiring 1,000 foot setbacks and industrial zoning. She commented that Rochester Hills approved the lease with only cursory due diligence.

Mike Powers, 3632 Aynsley, commented that the City should respond to Jordan Oil just as it did for the emergency weather event, by developing an emergency response system for things that are extraordinary such as the oil deal. He stated that the City should be able to come together to work with Jordan Oil to develop something that makes sense. He mentioned that Thornridge Subdivision held a meeting where 93 percent of the residents voted no when Jordan Oil approached their association.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

President Hooper announced that the General Election will be held on Tuesday, November 4th. He noted that the ballot will contain a Fire Millage Proposal to fund additional Firefighter/Paramedics and improve response times. He encouraged voters to research and become informed on the proposal, and commented that the Public Safety and Infrastructure Technical Review Committee is working on the development of informational brochures to be mailed to all residents. He noted that he was speaking for himself and encouraged voters' support for the safety of all residents.

Mr. Webber reported that Oakland County Commissioner Jeff Matis announced that the Commission will host a series of public meetings regarding the attempt by three counties, the Bankruptcy Court, and the City of Detroit to create a Great Lakes Water Authority. Meetings are scheduled for Wednesday, September 24th at 7:00 p.m. at the Older Person's Commission, and Thursday, September 25th at 7:00 p.m. at the Troy Community Center. He added that jurisdictions must make a decision on the Authority by mid-October.

Shreya Reddy, Rochester Hills Government Youth Council Representative (RHGYC), reported that the RHGYC held its first meeting of the year two weeks ago and elected Chris Russell as Chairperson, and Taylor Thorpe as Vice-Chairperson. She noted that subcommittees have begun work, and announced that the RHGYC will be helping at next week's Brooksie Way race, and participate in Carson's Community Days fund raiser, the Making Strides Against Breast Cancer 5K on Saturday October 25th, and host the Warming Tent at the Rochester Hometown Christmas Parade.

Mayor Barnett expressed his thanks to his team in Rochester Hills, noting that many good things are happening. He mentioned the following:

- Avon Road is now open. Thanks go to the Road Commission for Oakland County for their partnership, and to the residents of Christian Hills and other subdivisions for their patience during the times where there was additional cut-through traffic. - Those interested in obtaining information on the proposed Great Lakes Water Authority should attend the upcoming informational meetings.

- The Brooksie Way race will be held in and around Rochester Hills this coming Sunday. Residents with questions are encouraged to visit the race website, thebrooksieway.com, or call the Mayor's office with questions or concerns. Approximately 6,000 to 7,000 residents and visitors are expected to participate.

John Staran, City Attorney, noted that the original draft of the proposed Ordinance set penalties for ordinance violations for selling or distributing e-cigarettes to minors or minors purchasing or using e-cigarettes as a standard \$500 fine and a misdemeanor. He noted that the revised version included modifies those penalties in section 70-402 to a \$50 per violation municipal civil infraction for either selling or furnishing e-cigarettes to minors or for purchase or use by minors. He explained that current State Law with respect to tobacco products set an offense as a \$50 misdemeanor. He noted that the Ordinance closely tracks the language in the tobacco law. He commented that he also reviewed proposed legislation awaiting Governor Snyder's action which would prohibit the sale and distribution of e-cigarettes to minors. If that bill is enacted into law, that too would be a \$50 misdemeanor. He stated that making it a municipal civil infraction in the City's Ordinance decriminalizes it.

Mayor Barnett noted that Attorney Staran's e-mail response was included and was distributed to other Council members in answer to questions asked at the last meeting.

Keith Sawdon, Director of Finance, noted that the proposed Ordinance repeals Article 7, which deals with the Retiree Health Care Implicit Rate Subsidy in Chapter 82 of the City's Personnel Ordinance. He noted that the City created an Implicit Rate Subsidy for retirees who are allowed to buy City health care at City rates with their own funds. Under Accounting Standard Rules, the City had to report that liability and create a Trust to account for that subsidy. In January of 2014, when the City combined a move to one health care provider under HAP, the insurer was able to separate the active employees away from the retired employees, resulting in the retirees now paying their own rate and thus ending the subsidy.

He explained that the August 19th meeting of the Board of Trustees of the Retiree Health Care Trust voted to terminate the Implicit Rate Subsidy Trust, and he noted that all liabilities related to that Trust will be returned to the City. The proposed Ordinance follows through with this request.

Pam Valentik, Manager of Economic Development, explained that AdduXi is a privately held company with their main operations in France. Most recently, the company has seen tremendous growth in their North American market, and this has led to the need to establish a manufacturing facility in North America to support their sales. She noted that she has been working with AdduXi ownership since the first of the year to identify a facility in Rochester Hills over other options and she stated that she is pleased to report today that they have decided to lease a building on Enterprise Drive. With that building, they will need to bring in just over \$3.5 million in new machinery, equipment and computers. An application was received for Council's consideration for an Industrial Facilities Exemption, or tax abatement, on that new personal property.

She noted that the first step is for City Council to schedule a public hearing in

Bob White, Supervisor of Ordinance Services, explained that the City outsources the cleaning of City Hall, the DPS Facility, Fire Station 1 and the Rochester Hills Museum at Van Hoosen Farm. He added that the Administration is currently considering taking on more cleaning responsibilities at the Oakland County Sheriff's Substation. He stated that a request for proposal was posted on the Michigan Intergovernmental Trade Network, with eight qualified bidders responding. A committee made up of customers at City Hall, DPS, the Fire Station and the Museum reviewed all proposals, chose to interview the top four as two were tied for third low bid, checked references, and recommends the Kristel Group for the contract award.

President Hooper commented that he was glad to see the low bidder recommended. He noted that the two companies that previously held the contract in the past were not successful.

Mr. Webber noted that it appears that the City will save approximately \$35,000 from what was budgeted. He questioned what the terms are for the option to renew.

Mr. White responded that the contract is for one year, with an option to renew. At the end of the year, the company will be asked if it will hold its price for an extension.

Mike Hartner, Director of Parks and Forestry, noted that this is the next step in the stewardship management plan, and the consultant selected will help the Green Space Advisory Board (GSAB) develop management plans and priority rankings for all the green spaces and open spaces in Rochester Hills, consistent with the millage and the recent repurposing to fund stewardship activities, implement critical projects and set budgets, and evaluate the effectiveness of the programs. He explained that five good proposals were received, and two firms were shortlisted. Interviews were conducted by a committee of five, including GSAB Chairperson Gerald Carvey, and staff members from Planning, Building and Parks. Niswander Environmental is recommended for selection, as the firm has been involved with Green Space projects going back to the natural features inventory of the city and can hit the ground running with the first project of determining the budgetary requirements for the Trust. It is hoped that their report can be brought to Council before the end of the year.

Public Comment:

Melinda Hill, 1481 Mill Race, commented that while she has no problem with Niswander Environmental, she noted that little detail is being presented to Council on what they are proposing to do. She questioned why \$100,000 is requested when the initial services were suggested to be \$30,000 in 2014. She requested Council postpone a decision until more information is provided.

President Hooper requested Mr. Hartner address Ms. Hill's comments.

Mr. Hartner responded that the need for development of the details of the actual projects is precisely why professional assistance is needed to establish the scope and management plans for each of the sites. He explained that the dollar amount requested includes some implementation. He noted that as the projects progress, Council will receive a very detailed yearly breakdown site-by-site with estimates from a Professional Engineer who is also the implementer of many of the solutions. He commented that Niswander was chosen as it could provide most of the services for the projects identified.

President Hooper questioned whether the consultant will developed detailed cost estimates and priority rankings.

Mr. Hartner responded that management plans will be developed for each of the sites, and they will be prioritized. He commented that any one of the projects will include a multi-phase approach.

Council Discussion:

Mr. Wiggins commented that the first part of the project is to define the scope of what needs to be done, and the second phase is implementation. He questioned how the Administration knows that after the first \$30,000 is expended, \$70,000 will be needed in the next two years.

Mr. Hartner responded that the GSAB needs to provide Council with information on the entire size of what is going to be accomplished. He noted the problems communities are having with invasive species such as Phragmites. He mentioned that Niswander provided information on mitigation at River Bend Park which is estimated at \$250,000 for the wetland areas and \$200,000 of the upland areas. He pointed out that the intent of the Green Space program is to identify, prioritize and show a multi-year approach to tackle the projects. He stated the City will need to secure grants to undertake some of the larger projects.

Mr. Wiggins commented that as it seems possible that the City will need more than \$100,000, perhaps the study should be completed first.

Mr. Hartner responded that this amount is consistent with the project in the Capital Improvement Plan, and is a placeholder to begin. He explained that this item will return to Council and the City will need partners to complete the projects.

Mr. Wiggins suggested Council consider approving \$30,000 for the study and then have the item return for another vote.

President Hooper stated that staff is recommending \$100,000 be authorized now, with a budget amendment later for any difference. He noted that this does not mean that the entire \$100,000 will be spent.

Mr. Kochenderfer stated that as Council's representative to the GSAB, he was very surprised at the complexity of some of the issues that the GSAB is facing. He commented that if the GSAB is going to do this right, activities must be properly prioritized and will need the details of the management plans to be developed. He pointed out that the prioritization process could take at least a year in terms of what needs to be done with invasive species, access, or water features. He noted that these details will help the GSAB move forward with something that will be the most beneficial for the residents.

Allan Schneck, Director of DPS/Engineering, requested Council allow the City to enter into the agreement known as the North Oakland County Water Authority (NOCWA). He noted that a presentation was made to Council in March to provide a briefing on the progress toward such an initiative. He explained that the analytics and modeling have been completed and has proven that the communities are better collectively than apart. He commented that knowing that there is feasibility to create such an authority, the communities moved into governance and crafting a legal agreement. Multiple agency attorneys were involved, and the resulting proposed agreement is presented for Council's consideration.

President Hooper questioned what other member communities have acted on the proposal.

Mr. Schneck responded that Orion Township's Board has approved the agreement, and the City of Pontiac, represented by the Oakland County Water Resources Commission, has signed the agreement. He mentioned that Auburn Hills' City Council is considering the agreement at their meeting this evening.

Mr. Webber questioned how the agreement will be affected by the efforts to establish the Great Lakes Water Authority.

Mr. Schneck responded that the Oakland County Commissioners held a meeting to discuss the Great Lakes Water Authority. It was noted that the four agencies involved need to act upon a memorandum of understanding by October 10. If all agencies and stakeholders enter into such memorandum of understanding, a 200-day due diligence period will begin where those agencies will work together on the development of a lease agreement. He commented that as it is currently understood, all contracts currently in existence will be honored as bargained. If the four stakeholders that comprise NOCWA agree, then negotiations would

commence with the Detroit Water and Sewerage Board (DWSD) to enter into an agreement prior to the 200-day due diligence period.

Public Comment:

Melinda Hill, 1481 Mill Race, noted that although she is not a water user and has her own well, she is curious why there has been no additional information since a brief overview was provided on March 17th. She commented that it is unfortunate that a public process was not undertaken as this will affect all water users. She questioned what type of infrastructure cost the City will incur to be part of the process and expressed concern that other communities would provide services such as leasing out storage without receiving monetary benefit. She requested that a breakdown of cost to the communities be provided prior to a decision.

President Hooper noted that the cost breakdown is provided in Exhibit 1 of the proposed agreement. He commented that the Authority will combine together to purchase the water and the cost will be distributed back according to the set percentage in the contract. He stated that it is expected that the City will have a cost savings over what it pays right now.

Mr. Schneck concurred, stating that the savings will be in commodity cost.

Council Discussion:

Ms. Morita noted the following:

- Regarding the mediation and arbitration provision in the agreement, she questioned why disputes would not be handled in Circuit Court and a private arbitrator be paid instead.

- She expressed concern over the provision that communities must provide 18-month notice to leave the agreement, and cannot leave the agreement for the first three years.

- She questioned what would happen if one party does not pay its share. She expressed concern that the City would have to wait three years to determine that the agreement is not working.

She commented that she has had some interaction on some of the boards she sits on in other communities, and noted that one of the communities indicated that they did not have \$150 extra in their budget to pay for an item. She stated that this gives her concern when considering entering into this type of agreement with other communities knowing the type of expenditures that could be required.

John Staran, City Attorney, responded although he was the author of the first draft of the agreement, since that first draft many other attorneys have been involved in subsequent versions. The result is a group effort reflecting the modern trend to alternative dispute resolution rather than court litigation. He added that this was the sense of the attorneys in including the arbitration and mediation clauses, as well as recognizing how this association came about, as a cooperative unincorporated type of association, with minimal authority, and virtually no power to contract or expend money without the unanimous consent of all the members. He explained that should another party not pay its share, that very provision to resolve disputes would be triggered. He pointed out that it is the clear intent from this agreement that none of the members are going to be subsidizing or paying on behalf of each other and each member is going to be shouldering its own burden and paying its own costs according to an allocation. The City of Rochester Hills will serve as a treasurer to help with the administration of those costs; however, no member will be assuming liabilities on behalf of any others. He requested Mr. Schneck address the lead time to withdraw and the three-year commitment.

Mr. Schneck responded that the communities wanted enough time as a group to be able to plan and respond to someone's withdrawal from the Authority, and it was determined that 18 months is appropriate. The three-year period is tailored after the DWSD contracts, which are typically two years, followed by a reopener to a three-year contractual period, followed by another reopener and then five-year periods after that. He stated that the communities wanted a commitment from all stakeholders of three years.

Mr. Staran noted that when this concept was being developed, there were at least some preliminary discussion with the DWSD as to whether this is something that they would approve. Ultimately they were receptive to it; however, the DWSD wanted to ensure that it would be dealing with a real organization and not just a very loose band of otherwise individual customers that come and go. That also played into the decision to have a relatively long notice period to opt-out and the original three-year commitment.

President Hooper questioned whether there is any scenario where the City would be paying more it is paying right now for water.

Mr. Schneck responded no. He explained that the way it was modeled, each member brings different attributes to the table. Pontiac has 12 million gallons of storage, Auburn Hills has one million gallons of storage and Orion Township has 2.5 million gallons of storage. Rochester Hills brings sheer volume to the table as it is the biggest user and peaks at the appropriate time during the non-exclusionary period between 12:00 and 5:00 a.m. The DWSD expressed that while this is a great concept, they wanted to see that it could be put into practice. NOCWA was run as an authority this summer, filling schedules for reservoirs were amended and pressure schedules were altered with success. The mutual benefit between NOCWA and the DWSD is more cost avoidance on the DWSD's side. Knowing that the authority can control its draw and control its consumption provides cost avoidance for capital improvements on the DWSD's side, as they do not have to build bigger pumps. Also, the ability to negotiate with one agency provides a benefit to the DWSD.

He added that the City's customers will see no difference. The agreement states that each member community will maintain and operate its own systems. Unutilized assets in the region will be best used collectively.

President Hooper questioned whether all four members will see what they are paying for water decrease.

Mr. Schneck responded that the commodity rate will go down.

Mr. Wiggins cited Section 3 in the proposed agreement, and questioned what would happen if one community has a liability issue and cannot pay for something as part of a shared cost.

Mr. Schneck responded that under the agreement, if there is a capital expense that is deemed a benefit to all, it will be analyzed on a case-by-case basis. He stated that utilities are self-sustaining and he noted that while he was in Pontiac, the City never defaulted on a water payment. He noted that the utility is a separate enterprise fund versus the general fund and it is sustained by its rate payers. He commented that while the provision is in the agreement, he is not aware that any of the four agencies ever defaulted on a payment to the DWSD.

Mr. Kochenderfer commented that he believes this is a great idea; and he stated that it gives him comfort that as it is written in the agreement, the Authority is virtually powerless if there is not unanimity among the members. He pointed out that there are annual true-ups of the revenue allocation, and capital equipment expenditures are reviewed on a case-by-case basis. He stated that the City is not giving away any of its authority in the City. He commented that he sees only benefit.

Mayor Barnett stated that the City's largest bill is to the DWSD, and he noted that over the last several years the City has seen dramatic increases in the cost of water. He explained that the City has taken several approaches to try to curb those costs. He noted that the City evaluated the water reservoir discussion and enacted Ordinances to change water use to non-peak hours. He commented that there are not many other options available to lower water rates. He credited Mr. Schneck and Tracey Balint, Public Utilities Engineer, for their efforts to seek savings for the residents and collaborate with neighbors to seek efficiencies. He stated that it is his belief that the agreement is strong and the Authority is a benefit that goes directly to saving each resident money on their water bills.

A motion was made by Webber, seconded by Kochenderfer, that this matter be Adopted by Resolution. The motion carried by the following vote:

He noted that three Oakland County Sheriff Deputies and two City of Rochester Police Officers are under contract for ten months every year in the schools.

President Hooper noted that there are no changes in the percentage allocation between the communities.

Keith Sawdon, Director of Finance, responded that there were only slight changes in population between the communities.
