YS-99.1 Hogan Circle Yield to Connors Drive (North Intersection)
YS-99.2 Hogan Circle Yield to Connors Drive (South Intersection)
SS-137.1 All approaching traffic to STOP from Connors Drive, Bendelow Road, and Michelson Road at their intersection.

Whereas, Traffic Control Orders Nol YS-99.1, YS-99.2, and SS-137.1 have been issued by the Transportation Engineer under the provisions of the Rochester Hills Code of Ordinances, Chapter 98, Michigan Vehicle Code, MCL 257.1 et seq.; and

Whereas, said Traffic Control Orders cover:

YS-99.1 Hogan Circle Yield to Connors Drive (North Intersection)

YS-99.2 Hogan Circle Yield to Connors Drive (South Intersection)

SS-137.1 All approaching traffic to STOP from Connors Drive, Bendelow Road, and Michelson Road at their intersection.

Whereas, said Traffic Control Orders shall not be effective after the expiration of ninety (90) days from this date of issuance, except upon approval by this Council; and

Whereas, the Advisory Traffic and Safety Board has considered the issues pertaining to the Traffic Control Orders and recommends that the Orders be approved;

Resolved, that the Rochester Hills City Council approves the issuance of Traffic Control Orders YS-99.1, YS-99.2, and SS-137 to be in effect until rescinded or superseded by subsequent order; and

Now Therefore Be It Resolved, that a certified copy of this Resolution be filed together with the Traffic Control Orders, with the City Clerk of Rochester Hills, Oakland County, Michigan.
