LEGISLATIVE & ADMINISTRATIVE COMMENTS

Mr. Webber announced that the Rochester Regional Chamber of Commerce's Community Outlook Luncheon is scheduled for Wednesday, February 20, 2013, at 11:30 a.m. at Oakland University.

Mr. Kochenderfer congratulated Mr. Webber for his addition to County Executive L. Brooks Patterson's "Elite 40 under 40" list.

Mr. Tisdell and **Mr. Yalamanchi** echoed congratulations to Mr. Webber for his inclusion on the list.

Chris Tower, Rochester Hills Government Youth Council (RHGYC) Representative, announced the following:

- The RHGYC's Green Team Action Committee has reusable grocery bags for sale, with proceeds to be used to purchase and plant trees in Borden Park. Bags will be available for \$3.00 from RHGYC members and at Busch's on Saturday and Sunday.
- RHGYC members are busy planning their annual 5K Run/Walk, to be held this year on June 15th at Borden Park. Interested runners and walkers can access online registration for the event at www.goracego.com.
- The RHGYC Education Action Committee is in the midst of a Strive 4 a Safer Drive program, with activities scheduled to promote text-free driving for teens. The RHGYC received a \$2,000 grant to fund their program activities, which include promoting the signing of cards by teens to pledge that they will not text and drive at the Crosstown Showdown at Oakland University; an upcoming game show at

Adams High School during a lunch hour to promote safer driving; and a creativity contest where students are encouraged to design a poster, write a song or rap, or submit a video or any medium that promotes safe driving. First, second and third place winners will be chosen from the submissions, with the winners receiving prizes.

Mayor Barnett commented that the RHGYC is considered a model group throughout the state. He announced the following:

- Winter Property Taxes are due on February 14, 2013.
- The City received notification that work will begin on February 7, 2013 on reconstruction of Auburn Road from Ryan Road to Dequindre in Macomb County. Work is expected to continue through late July, with Auburn Road closed to traffic during the process. Access will be given to businesses along that stretch. Information is available on the project at www.macombcountymichigan.gov/roads.
- Those wishing to attend the Community Outlook Luncheon on February 20th at Oakland University should purchase tickets as soon as possible; the luncheon is usually a sell-out.
- Congratulations go to Mr. Webber for his inclusion on L. Brooks Patterson's "Elite 40 under 40" list.
- There is still time to donate RecycleBank points to the Green Schools Program to benefit Long Meadow and University Hills Elementary Schools.

Mayor Barnett displayed photographs showing the progress of the Calf Barn Restoration Project at the Rochester Hills Museum at Van Hoosen Farm. The roof is being raised on the project, which is being privately funded. Donations are welcome, as the project is still in Phase I.

Fred Phillips, President, Friends of the Clinton River Trail (FCRT) and **Kristen Wiltfang**, Planner, Oakland County Planning Department, and FCRT member, were in attendance.

Mr. Phillips gave the following presentation:

IMPLEMENTING A UNIQUE LOOK AND FEEL FOR THE CLINTON RIVER TRAIL

About the Friends of the Clinton River Trail:

- An all volunteer group.
 - * Friends of the Clinton River Trail is committed to promoting the Clinton River Trail as a safe and enjoyable recreational destination.

Goals:

- FCRT Goals:
 - * Short-Term - Safe Crossings
 - * Mid-Term - One Trail/Five Cities

A map of railroad lines as they existed in 1876 was displayed, along with a map noting proposed trails. Governor Rick Snyder wants to bolster the state's existing trails, connecting several stretches to create a single, 599-mile stretch from Belle Isle in Detroit to Wisconsin.

Connections - The Great Lake-to-Lake Trails:

- 260-plus Mile Route
- Links 15 existing trails
- Kellogg Foundation Funding
- Started in 2007
- Route 1 - South Haven to Port Huron

Crossroads:

- The Key Link in Southeast Michigan's Trail Network

He noted that there are three types of users: local users, day-trippers, and overnigheters. He explained that local users spend no money as they use the trail strictly for recreation, day-trippers may visit and stop for lunch, and overnigheters travel on longer trails and may stop for lodging. He noted that the longer a trail is, the more economic value to the community it provides.

Look and Feel:

- Addresses Many Goals

Tara Presta, Chief Assistant and **Mike Hartner**, Director of Parks and Forestry, were in attendance.

Mr. Hartner noted that the Friends of the Clinton River Trail (FCRT) is a group that has provided great financial support. He stated that the application deadline for the Michigan Land Trust Grant Program is April 1, 2013. He explained that each of the three individual communities must present its own project; however, the projects will be coordinated for continuity. He mentioned that Ms. Presta will coordinate the application process.

Ms. Presta noted that the grant program seeks groups that have a connection, collaboration and partnership. She commented that the proposed project should put the FCRT in a good position for consideration of a grant; and stated that should the program choose not to fund one portion of the project, another portion could still be chosen for funding.

Mr. Hartner recognized the efforts of Oakland County Planner Kristin Wiltfang.

Mr. Yalamanchi and **Mr. Kochenderfer** each expressed their congratulations to staff and the FCRT for their work, noting that the Grant Program provides a way for development with limited resources.

Public Comment:

Brandon Noll, representing 6841 North Rochester Road, stated that Fred Ferber, owner of that portion of the property, remains in objection to the historic designation and wishes for the property to be removed from the list of potential historic sites.

Eric Mozer, 182 Bedlington, Trustee of the Reinhold J. Mozer Trust, requested Council not allow the designation to proceed. He commented that his father requested this property be removed from the potential list ten years ago. He

commented that his father has spent much money on this building, and has replaced all of the windows in the part being considered for historic status. He mentioned that the go cart track business has now closed.

Greg Obloy, 411 Andover Road, Bloomfield Hills, stated that on behalf of the Corporate Park of Rochester Hills, he opposes the designation. He commented that at each meeting he has attended, only one or two residents speak for the designation, and the two owners speak vehemently against it. He mentioned that when there is a grass roots support for an ordinance, customarily hundreds of residents will support it; and pointed out that there is no support here. He likened the designation to a taking without compensation and commented that preserving the two acre portion of the front of this property will not result in a development that will provide the best return for the residents of the area. He stated that the Planning Commission voted unanimously against the historic district.

President Hooper stated that the resolution of the Planning Commission was that they reviewed the Historic Districts Study Committee report regarding creation of a locally-designated historic district at the National Twist Drill site and determined that the listing will have an impact on the property with respect to the City's Master Land Use Plan and any other development-related issues. He noted that the Public Comment in regards to the Planning Commission meeting was not accurate. .

Ed Anzek, Director of Planning and Economic Development, stated that a reapproval is required for the plat, which was given its preliminary final approval in 2010. The previous plat went to the State to begin the final plat process, and was subsequently denied as it was a week or two beyond the two-year timeframe required. He explained that a reapproval is required to refresh the date in the process. He pointed out that in accordance with newly-passed Legislation, the Planning Commission was required to provide public notice; and subsequently heard resident input and recommended additional conditions including a green screening wall to mitigate the residents' views of the retention basin and surrounding wall. He explained how an arborvitae wall would be installed, and noted that in lieu of turf block, quality topsoil would be placed and leveled with seed and mulch. He noted that the conditions were modified to reflect this change.

Public Comment:

Warren Degrendel, 695 Tewksbury, stated that a meeting held on January 25th to discuss the retention basin yielded a solution that meets with his approval. He thanked Council for its efforts in facilitating a resolution.

Mayor Barnett stated that over the last two years, he began to investigate the possibilities of creating a community garden in Rochester Hills. He noted that during his visit to Germany in 2011, he saw many community gardens throughout Europe and commented that the gardens have been integrated into the European culture. He noted that two groups of individuals have been instrumental in

promoting the concept; the seniors from the Older Persons' Commission and Rochester Hills Government Youth Council members are passionate about pursuing a community garden. He stated that meetings were held with Dinosaur Hill Nature Preserve leadership, as they help coordinate the City of Rochester's garden, which is located in between their Department of Public Works Facility and Dinosaur Hill. He commented that Rochester is already talking about expanding their program.

He explained that the location selected is in Wabash Park, as the garden would be centrally located and near a high concentration of apartments and condominiums. He pointed out that the park is open, flat and accessible, and has been underutilized. The park property already has a developed parking lot and an underutilized playground. The Administration proposes a phased project, with a Phase 1 amount of \$30,000 needed. He stated that the Administration plans to engage partners in the community, including garden groups and associations, along with the RHGYC. A formal request will be submitted to the Rochester Rotary Club to encourage their engagement as well. Four-by-four foot plots will be leased to residents of the community, and the garden will be managed by Dinosaur Hill Nature Preserve. A list will be developed on plants that are permitted.

***Mike Hartner**, Director of Parks and Forestry, noted that research yielded a book, written by Mel Bartholomew, which provided information on the development of a garden consisting of four-by-four boxes filled with peat moss and vermiculite. He commented that this method can yield the same quantities of produce in approximately twenty percent of the space of a traditional garden. The garden will have several raised handicap-accessible beds, and pathways will have the same surface as is used on the Clinton River Trail. The pilot program will have room for expansion.*

***Mayor Barnett** noted that a final list of regulations for the garden have yet to be spelled out.*

***Tara Presta**, Chief Assistant, stated that her role is to identify funding sources for the garden and Council's support would bolster the grant application process. She commented that companies and businesses want to support the initiative, and commented that Home Depot, Scott's Miracle Grow, and the Brooksie Way Mini-Grant Program have been approached. She mentioned that RecycleBank has agreed to provide a \$2,500 grant to fund the start up phase.*

***Mayor Barnett** commented that the City is "Innovative by Nature" and is presenting something that it can deliver as a new recreational opportunity for its residents.*

Public Comment:

***Ruthann Bajorek**, 64 Cross Creek, stated that while she wants to support the project, she is not happy with plans for a four-by-four foot plot. She stated that she is a volunteer gardener at Meadow Brook Hall and is involved with Rochester's community garden and would recommend a larger plot. She noted that Rochester's garden features four-by-eight foot plots.*

Ella Steele, 230 Randolph, noted that she is an Advanced Master Gardener, and commented that gardens create a community where gardeners get together, exchange ideas and socialize. She stated that a proposed fee of \$30 is too much for a four-by-four foot square plot. She mentioned that the four-by-four foot square plot is an alternative style of gardening best suited to someone with no options for space and is not practical for sprawling vegetables. She noted that Mr. Bartholomew's book recommends that small plot gardens be placed by back doors where gardeners can attend to them every day. She commented that the First Congregational Church has installed four-by-twelve foot beds and finds it difficult to contain vining plants. She stated that recommendations are that the soil be replenished throughout the season and she hopes that it will be an organic garden.

Lee Zendel, 1575 Dutton Road, stated that the resulting cost will be approximately \$100,000 and questioned where the funding would come from. He commented that he supports the idea of a community garden; however, there should be conditions imposed on the users of plots. He noted that it should be a condition of plot rental that all materials used should be certified Organic by the Organic Materials Review Institute (OMRI), and no herbicides, commercial composts or manure composts should be permitted.

Michelle Thorpe, Rochester Hills Government Youth Council (RHGYC) Representative, stated, that the RHGYC fully supports the proposed project. She commented that RHGYC members are looking forward to having a plot.

Scot Beaton, 655 Bolinger, stated that he wholeheartedly supports the idea; however, he questions whether the residents of the neighborhood surrounding the park have been consulted. He suggested that 24-hour surveillance be included and commented that an online webcam could be incorporated.

President Hooper questioned whether the neighboring owners have been contacted.

Mayor Barnett responded that the neighborhood has no formal association; and noted that staff has discussed how to introduce the project to the neighborhood. He mentioned that the park is used now as a place for pick-up soccer games.

Mr. Hartner explained that the park property was originally a community well site. He noted that at one time, ice rinks were built and a Frisbee golf course was developed. He commented that the playground is getting some use and stated that developing the park for a good use is a good way to push out any undesirable use of the property.

President Hooper suggested that a community meeting be held. He questioned whether the garden will be deemed for organic materials only.

Mayor Barnett responded that the garden would be modeled after Rochester's garden, which is organic. He stated that a water source will be brought in to the site. He commented that while the cost is still a guess, the Administration believes that the garden can be developed for much less than the amount proposed.

President Hooper questioned whether once the City provides the land and the structural improvements, the garden will be run by Dinosaur Hill and the City will not be required to provide any additional support.

Mayor Barnett responded that a definitive operating agreement will be brought forward for Council's review. He stated that it is the Administration's goal to have a garden in by Memorial Day this year.

President Hooper questioned whether the proposed four-by-four foot plot size is too small.

Mr. Hartner responded that the plants will not be grown in topsoil, and commented that the existing ground is solid clay. He explained that the beds will be raised up off of the surface, built up with six inches of peat moss, vermiculite and blended compost, and can be hand-watered, avoiding the need for any irrigation system.

Mayor Barnett noted that while the City has done some research on optimum plot size, he is open to continued discussions with Dinosaur Hill.

President Hooper suggested that a combination of sizes be available.

Council Discussion:

Mr. Yalamanchi suggested that individuals could collaborate on larger size plots and mentioned that a well could be considered for a water source. He questioned how the garden would be fenced and how Dinosaur Hill would manage the garden.

Mr. Hartner responded that a 7-1/2 foot fence is planned. He stated that Dinosaur Hill has an advisory board to review and set policies.

Mr. Yalamanchi questioned whether any other City properties could be utilized, such as Van Hoosen Farm.

Mr. Hartner responded that there is a garden on the Farm site already. He added that they have bees there that could interfere with garden activities.

Mayor Barnett commented that there will also be a push to encourage businesses to add plots to their parking lots and entranceways.

President Hooper questioned whether leasing garden plots would violate the Parks Charter Amendment.

Mayor Barnett responded that the concept has been reviewed by City Attorney John Staran and he indicated that gardeners would not be allowed to sell the produce they grow, as it would change the underlying zoning to agricultural. He stated that gardeners can consume or donate their yield. He commented that the short-term rental of plots would not violate the Parks Charter Amendment.

Mr. Kochenderfer questioned whether there is an estimate of annual maintenance costs once the infrastructure is in place.

Mayor Barnett responded that maintenance costs should be relatively minor once set-up is complete and stated that estimates based on neighboring gardens range from \$5,000 to \$7,000 at the high end. He explained that Rochester's budget for their garden is approximately \$3,000 per year. He noted that the water bill should be similar to that for a park drinking fountain.

Mr. Hartner added that watering costs could be several hundred dollars a year.

Mr. Kochenderfer questioned whether other communities with community gardens have been consulted as to how feasible a four-by-four foot garden will be.

Mayor Barnett mentioned that Raising Rochester, a group supported by Kidz First Pediatrics and Dr. Jay Mitchell, has a goal to encourage the development of over a 1,000 gardening beds throughout the community. He stated that the Administration's research indicates that this style of gardening can be successfully done. He commented that while the concerns mentioned today during Public Comment are valid, the four-by-four foot type of garden has been recommended by other experts.

Ms. Presta responded that Dinosaur Hill would create an educational program with information provided on square foot gardening.

Mr. Tisdell suggested that Dinosaur Hill be asked to attend a Council meeting to answer any questions. He commented that Council is being asked to give a green light to the project to demonstrate its support to some of the business partners that are being asked for financial assistance.

Ms. Presta stated that approval is requested for \$30,000; and the Administration intends to bring the project in under budget securing sponsors and partners.

Mr. Webber commented that while he has concerns over the cost, and the details have yet to be worked out, he supports the garden concept as it can provide a great benefit to the community.

Mr. Yalamanchi stated that while there is nothing wrong with a four-by-four foot garden plot, he would suggest the Administration also consider an eight-by-eight foot plot to allow for collaboration.

Mayor Barnett responded that Rochester began with a 42-plot garden in 2011 which sold out. He noted that last year they had 97 plots; and this year, they will be adding 42 more.

Mr. Rosen commented that the garden should be kept in the context of recreation and should not be considered as a business. He requested costs be kept as low as possible.

A motion was made by Tisdel, seconded by Yalamanchi, that this matter be Adopted by Resolution. The motion carried by the following vote:

Whereas, community gardens empower residents to become more active in their communities, cultivating volunteers and leaders who come together to preserve open space and create gardens for the benefit of present and future generations.

Whereas, community gardens educate residents about land stewardship, providing an informal classroom for children and adults to learn skills caring for the natural environment.

Now Therefore Be It Resolved, that the Rochester Hills City Council supports the development of the city's first-ever sustainable community gardens at Wabash Park and authorizes the initial funding of \$30,000 for the development of the Wabash Community Garden.

Be It Further Resolved, that upon approval, the Mayor and Administration will prepare an agreement with Dinosaur Hill on an operational plan to be approved by the City Council.

President Hooper noted that 24 applications were received for City Clerk subsequent to the announcement of Jane Leslie's retirement and the posting for the position. He explained that 14 applicants met the criteria for the position; and the City Clerk Search Committee consisting of himself, Mr. Webber, Mr. Tisdel, Mayor Barnett and Keith Sawdon, Finance Director, selected eight for initial interviews. The process was facilitated by Pamela Gordon, Director of Human Resources, and all meetings were held in compliance with the Open Meetings Act. Subsequently,

four finalists were chosen, including two internal and two external candidates. The finalists were interviewed at the Special City Council Meeting this afternoon.

Council Discussion:

Mr. Yalamanchi thanked the four candidates participating in today's interview process and stated that he was impressed with all four.

Mr. Webber expressed his appreciation to Ms. Gordon and the Human Resources team for their organization of the process.

Mr. Rosen thanked the candidates that were interviewed today and stated that he wished to make a nomination.

Mr. Tisdell expressed his appreciation to Ms. Gordon and stated that it was a very simple and efficient process. He commented that the quality of the applicants that responded to the posting was exceptional, and he spoke to the high regard that individuals in the clerking community hold for the City of Rochester Hills.

Mr. Kochenderfer stated that he has been a part of many hiring processes and commented that he has not seen one that has been more organized and professional than this one.

President Hooper commented that this is a difficult decision for him, as it is his opinion that any of the four candidates would serve the City well. He stated that any vote on his part is not a vote against anyone; it is a vote for the best qualified candidate.

President Hooper Opened the Floor For Nominations.

Mr. Rosen stated that his nomination is that of a candidate who recognizes the importance of maintaining the City's institutional memory long into the future. He noted that the candidate he wishes to nominate is one who has been, and who will likely continue to be innovative in performing and developing election and record keeping processes for their efficiency and effectiveness. He commented that the candidate he chooses to nominate has a high regard for the city's residents and businesses, and is one who has undertaken and completed difficult projects for the Clerk's office. He stated that this candidate has indicated that she will undertake the development of a strategic plan for the Clerk's office with a view for the future. He nominated **Susan Galeczka**.

Mr. Webber stated that the Clerk is responsible for some of the most important functions of a City government, including records retention, the election process, and customer service. He nominated **Tina Barton**.

Mr. Tisdell mentioned that the scoring and ranking process during the initial series of interviews yielded a first-place candidate and a three-way tie for second.

He commented that there was a great difference in scoring between the first place candidate and the rest. He concurred with the nomination of Tina Barton.

Seeing No Further Nominations, President Hooper Closed the Floor for Nominations.

Mr. Kochenderfer stated that any of the four interviewed candidates were qualified to serve, and commented that Council must select that unique candidate with broad and deep experience in all areas. He noted that Ms. Barton has both broadness and depth to her qualifications.

Mr. Yalamanchi noted that the interview process was a good exercise and yielded one candidate that he strongly wishes to support.

President Hooper mentioned that all four candidates showed great strength, and commented that his decision comes down to selecting the best possible candidate.
