**Resolved,** that the Rochester Hills City Council approves the Contract/Blanket Purchase Order for construction of Avon Creek Phase II Restoration project to Inland Lakes Landscaping Corporation, Pontiac, Michigan in the amount not-to-exceed \$138,326.90 with a 10% contingency of \$13,832.69 for a total not-to-exceed amount of \$152,159.59 and authorizes the Mayor to execute a contract on behalf of the City.
