**SUBJECT:** Amendment to Resolutions appointing Citizen Representatives to City Council Communication Committees

---

City Council, at its regular meeting of February 2, 2005 adopted Resolution RES0029-2005 amending *City Council Rules of Procedure* to change the Citizen Representatives terms on the City Council Communications Committees from three-years to one-year increments to coincide with Council and Youth terms and to provide more flexibility for the Citizen Representatives. In addition, the February 16, 2005 Consent Agenda contains resolutions for Council's consideration to amend the respective City Council Communication Committees *Bylaws and Rules of Procedure* to reflect the appropriate term length.

The final step of this process is to amend the Resolutions that appointed the Citizens Representatives to the Communication Committees to reflect the one-year term. The resolutions to be amended are as follows:
