PUBLIC COMMENT

Scot Beaton, 655 Bolinger Street, stated that while the contract for a new City monument sign has already been awarded and its installation is expected to proceed, an opportunity still exists for the final sign design to be reviewed by either the Planning Commission or the Zoning/Sign Board of Appeals (ZBA) at a December meeting.

John Staran, City Attorney, stated that while the ZBA may look at sign square footage allocation among multiple tenants, no one at the City makes any aesthetic review or judgment of signage.

Mr. Beaton questioned whether the Planning Commission reviews proposed signage as a part of the site plan review process.

Mr. Staran responded that signage is reviewed for site plans only if presented as a part of the renderings.

Vince Munglioli, 3435 Palm Aire Drive, Executive Director of the Holiday Helpers charitable organization announced the following:

- The Holiday Helpers Giving Tree is in place at City Hall. Everyone is encouraged to take a name off of the tree to purchase a gift for those less fortunate.
- The Village of Rochester Hills is hosting a Stuff-A-Truck event on Saturday, December 3rd. Donations of non-perishable food, clothing and children's gifts are requested.
- Limelight Restaurant is the location for the Holiday Helpers' No Child Without a Christmas event. Those bringing a new unwrapped toy for donation will be able to enjoy a free buffet.

Mr. Munglioli reported that in the past year the Holiday Helpers distributed 3,200 pounds of food and took care of 245 individuals and 70 families. He mentioned that two years ago, the group supported twelve families.

Pauline Holeton, 2392 Barclay, Shelby Township, requested that Council consider a moratorium on the installation of Smart Meters in Rochester Hills. She expressed concern regarding the meters' use to change the way that electric usage is tracked and billed, and questioned the health risks associated with the electromagnetic fields and radio frequencies they emit. She distributed a packet of information she had compiled regarding Smart Meters to Council members, and stated that the meters violate the Fourth Amendment's right to privacy in allowing for consumer profiling by utilities.

Susan Stroud, 283 Whitney, stated that Smart Meters are being installed in her subdivision. She expressed concern about health effects and stated that there are no mandates by the Federal Government for their installation and use. She commented that communities are fighting their installation from California to Maine and stated that these meters are being installed quietly and quickly before people speak up.

Patty Faultley, 3063 Eastwood Drive, stated that she received a letter indicating that her home would receive a Smart Meter. She commented that she called DTE Energy to tell them she did not want this meter and was informed by the DTE

Representative she spoke with that their installation is a Michigan mandate and she could do nothing to stop its installation. She expressed her concerns of the health effects of these meters and commented that they will be an invasion of privacy. She requested Council consider taking action soon as once the meter is installed it will be nearly impossible to get it removed.

Lonnie Collett, 3063 Eastwood Drive, stated that citizens are being pushed to accept Smart Meters and commented that he does not want them. He mentioned that it is time for Americans to stop what is going on in the country regarding their forced installation.

David Stroud, 283 Whitney, commented that he is against the installation of Smart Meters and expressed concern about the radio frequencies they emit. He mentioned that his electric meter is on the wall directly outside of where his couch is located in his living room and stated that if he wishes to have the meter's placement changed, it will be at his own expense. He expressed concern that the chips in the meters will allow the utilities to see what is going on inside of one's home and noted it could allow a utility to bill more for appliance use during certain times of the day. He stated that in areas where these meters have already been installed, utilities are suggesting that appliances be used after midnight. He noted that various studies that once concluded that cell phone radiation is not harmful have now reported that there could health effects from exposure, and questioned what will happen when it is found that these meters are also harmful.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

President Hooper congratulated the incoming and returning Council Members and Mayor Barnett. In response to Public Comment, he stated that Council approved the budget for the installation of a new monument sign, and commented that it is reasonable that when it does come back again for consideration, the Planning Commission could be requested to review the proposed design. He noted that Smart Meters are regulated by the Michigan Public Service Commission (MPSC) and requested that DTE Energy (DTE) representatives be asked to come before Council to present information regarding the installation and use of these meters. He mentioned that water meters in the city are remotely read and commented that during discussions regarding proposed water reservoirs, many residents suggested a meter reading device to encourage a shift in water demand to off-peak times to reduce water rates. He noted that the City currently does not have a water billing system in place that includes consideration of the time of water use.

Mr. Klomp congratulated the incoming Council Members and Mayor for a successful election and commented that he looks forward to a prosperous two years. He thanked the residents who spoke tonight regarding Smart Meters and stated that he will review the information distributed by Ms. Holeyton. He announced that the Ram's Horn Restaurant, together with The Professional Group, are hosting the third annual Feed the Hungry dinner tonight from 4 p.m. through 9 p.m., and mentioned that the event is an example of the importance of giving back in corporate citizenship. He wished everyone a Happy Thanksgiving.

Mr. Kochenderfer expressed his appreciation for everyone's well wishes and stated that he looks forward to serving the City's residents. He thanked the residents who presented information regarding Smart Meters and noted that his parents live in Shelby Township and were also notified of their installation.

Mr. Rosen welcomed the new and returning Council Members and Mayor and wished everyone a happy and safe Thanksgiving.

Mr. Tisdell expressed his thanks to Leanne Scott, City Council Coordinator, for her work to help get the incoming Council Members started and commented that he is looking forward to serving. He mentioned that he believes that a Smart Meter was already installed at his home.

Mr. Webber congratulated the returning and new Council Members and the Mayor and stated that he looks forward to working with everyone. He stated that he will review the information distributed regarding Smart Meters. He announced that the Rochester Hometown Christmas Parade will be held on Sunday, December 4th, and mentioned that the Grand Marshals for this year's parade are Russ and Kathy Shelton.

Mr. Yalamanchi congratulated Mayor Barnett and the incoming and returning Council Members. He requested Mayor Barnett arrange for DTE to come before Council to address the installation of Smart Meters and thanked those in attendance for bringing the meters to Council's attention. He wished everyone a Happy Thanksgiving.

Eric LaRose, Rochester Hills Government Youth Council Representative (RHGYC), expressed congratulations on behalf of the RHGYC to the Mayor and incoming and returning Council Members. He reported that the RHGYC is planning a Youth Summit for Saturday, March 10th, and commented that fund raising for the event is ongoing. The group completed one returnable bottle and can drive which netted \$90 and will undertake another drive next week. Members are also selling Achatz Pies for the holidays, and anyone interested in purchasing a pie should contact Leanne Scott, City Council Coordinator and Adult Advisor to the RHGYC. He mentioned that the RHGYC previously held a Youth Summit in 2008, which was attended by over 100 students. He announced that RHGYC members will participate in the Rochester Hometown Christmas Parade in downtown Rochester on December 4th dressed as toys from each of the last six decades to celebrate this year's theme, "Six Decades of Christmas Fun". On behalf of the RHGYC, he wished everyone a Happy Thanksgiving.

Mayor Barnett welcomed the newly-seated Council Members, noting that their work begins this evening. He expressed his appreciation to the RHGYC for participating in the Oath of Office Ceremony on November 17th, and thanked Ms. Scott and Jane Leslie, City Clerk, for their efforts in planning and coordinating the Ceremony. He wished everyone a Happy Thanksgiving and noted that City Hall will be closed on Thursday and Friday in observance of the holiday weekend. He announced the following:

- The Oakland County Sheriff's Office Coats for the Cold collection is continuing. A barrel is available at City Hall for donations of gently-used coats.
- Residents are encouraged to select a name from the Holiday Helpers Giving Tree in the lower level of City Hall.
- The Road Commission for Oakland County issued a press release which announced that the Livernois Bridge will be funded for reconstruction in 2013.
- Richard and Carol Stinson, residents of King's Cove, are celebrating their Fiftieth Anniversary this week.
- Lagniappe, downtown Rochester's celebration to light the Christmas Lights, will be held on Monday, November 28th.
- This is the 60th year for the Rochester Hometown Christmas Parade. Over 150,000 people are expected to attend the Parade on December 4th, which will be broadcast live by WXYZ-Channel 7.

Mayor Barnett commented that he has received several emails regarding the installation of Smart Meters. He stated that the City of Rochester does not have a moratorium; however, their Council has asked DTE to stop installing the meters until the utility can come before Council to discuss the process, expected one week from tonight. He noted that he received an opinion prepared by Beier Howlett, the attorneys representing the City of Rochester, regarding their Council's role, and stated that he forwarded this email to Council members. He mentioned several questions and answers contained in the opinion, noting that the City's role may be very minimal and the residents' themselves may have a bigger role in achieving their desired results. He requested John Staran, City Attorney, discuss the role of Council in consideration of the meters in the community.

John Staran, City Attorney, stated that he looks forward to reviewing a copy of the materials presented this evening, and commented that he certainly does not have the knowledge base to comment on the questions raised of the program or safety of the meters. He stated that from a legal standpoint, as Mayor Barnett mentioned, City Council's role is a very limited one. The City of Rochester Hills does not govern or regulate DTE's operations, services, manner in which they provide those services, or the rates that they charge for their product, which is electricity. Rather, those things come within the exclusive governance and jurisdiction of the MPSC, the entity that governs public utilities in the State of Michigan. He stated that they are the body who have the authority to either advance or halt this program or other aspects of DTE's operations. He noted that this does not mean that the City of Rochester Hills cannot provide a sounding board to get answers to the questions posed by the residents. From a legal standpoint, however, it is not the City's authority to either stop or advance this program.

Mr. Yalamanchi questioned whether the Administration could request that DTE make a presentation to Council regarding the meters. He noted that the information presented tonight by the residents noted that Southfield, Shelby and Oak Park have adopted resolutions to submit to the MPSC expressing concern. He requested that Council take steps to join the other cities to express the residents' concerns regarding the meters' effects on health and safety.

President Hooper suggested that a resolution be drafted for consideration on

the next Council Agenda, and DTE be requested to present information on the program to Council.

Mayor Barnett suggested that Council might wish to wait for the presentation by DTE before adopting a resolution.

Mr. Yalamanchi commented that a resolution could be adopted to inform the MDSC that the residents have expressed concerns regarding the effects of the meters on health and safety.

President Hooper concurred that a resolution could be considered.

Mayor Barnett reported that a Pit Bull attacked two smaller dogs in the northern portion of the city during the past week. He mentioned that previous Council Members had much discussion regarding the Pit Bull breed. He noted that the attack occurred on Monday, the City followed its Dangerous Dogs Ordinance, and the offending dog was euthanized on Friday. He stated that no law put into place could have eliminated the attack; however, Council should be pleased that the Ordinance they adopted allowed for a resolution within a week of the action.

Mr. Yalamanchi questioned whether the not-to-exceed amount requested covers the entire two year period and how it is determined when the review services are to be used.

Scott Cope, Director of Building/Ordinance Compliance, stated that the services are used as needed as a backup for current staff or in the event that City staff cannot keep up with an increase in workload. He reported that while the service has been available, it has not been used for the last two or three years.

Mr. Yalamanchi questioned why the firm in Grandville was selected over the other companies under consideration from Troy and Shelby Township and if the firm's distant location was considered.

Mr. Cope responded that Code Source was selected based on qualifications, as the individual who will perform the reviews is a Registered Architect with the State of Michigan. He added that the City's experience with Code Source from 2005, 2006 and 2007 provides City staff with a comfort level that the review services will be performed satisfactorily. He noted that the City's prior experience is that when a review is not performed properly, it takes City staff much more time to clear things up. He noted that Code Source's location does not present any problems, as plans for review are sent through the mail by next-day delivery. He added that Code Source staff have no problems in coming to the City whenever necessary.

Keith Sawdon, Director of Finance, stated that the City has participated in the Police School Liaison Program for a number of years; and explained that each year, the Cities of Rochester Hills, Rochester and Oakland Township work with the Rochester Community School District to develop the program budget. He noted that tonight's request is for Council to authorize the Mayor to sign the Agreement. He explained that the program's total budget for 2011-2012 is \$559,824 and stated that the Rochester Community School District covers any overtime required and contributes 25 percent toward the total cost. The remaining dollars are split between the three community partners, based on school population. Rochester Hills' percentage of school children enrolled is the highest of the three communities, at 69 percent.

Mayor Barnett noted that the program's structure changed in 2009 and the School District has increased its share of the total program costs, moving from 19.7 percent to 25 percent. He pointed out that he, Jaymes Vettraino, City Manager for the City of Rochester, James Creech, Oakland Township Supervisor, and District officials meet regularly and commented that while many districts have cut their Liaison programs, this program remains vibrant and healthful.

Mr. Webber commented that the program has been seen as worthwhile for many years and noted now that the District has moved to cover 25 percent of the program costs, it has lessened the financial burden to the City.

Mr. Klomp commended Mayor Barnett for his efforts to lower the City's percentage of contribution to the Liaison program. He questioned whether the increase in the total program costs over last year are due to increases in the police contract rates.

Mayor Barnett responded that as the costs for Oakland County Sheriff Deputy services increase, so do the costs for the Liaison program. He commented that this is an almost exclusively labor-driven budget item, with little cost included for materials.

Mr. Klomp stated that it is an important program. He thanked Mayor Barnett for lowering the City's costs for the program by almost \$70,000 in four years' time.

Mayor Barnett expressed his appreciation to the Rochester Community School District for their efforts.
