LEGISLATIVE & ADMINISTRATIVE COMMENTS

Ms. Mungioli congratulated the following City Council Candidates: President Deel, Mr. Walker, Mr. Berard, and Ms. Moreland. She stated that she looks forward to them sharing their position on the issues with residents while on the campaign trail. She wished them the best of luck.

Mayor Barnett provided the following updates:

- He stated that the Crowdfunding Campaign for the Innovation Hills Playground was launched on April 1st and will end on May 31st. He stated that if the City successfully raises \$50,000 they will be granted a \$50,000 match through the Michigan Economic Development Corporation (MEDC). He shared that as of today they have raised just over \$33,000. He encouraged everyone to share the campaign information on their social media pages and make a contribution.

- He announced that the Parks and Natural Resources Department is hosting Arbor Day on Friday, April 30th with two sessions available; 3:00 p.m. at Meadowbrook Hall and 4:00 p.m. at Innovation Hills. He shared that they will be planting a tree on the trail at Innovation Hills in honor of Brooks Patterson's legacy and the Brooksie Way. He shared that this is also a way of honoring the community's legacy of supporting tree planting. He stated that the City will be giving away 250 free trees to residents to plant in the public right away, an initiative funded by the Tree Fund.

- He stated that construction season is kicking off and letters have been mailed to residents with information on upcoming projects. He shared that the

two larger projects that will take place this summer are the Hamlin Road and Butler Road reconstruction. He noted that all of the projects can be found on the City's Interactive Construction Projects Map. He stated that the City looks forward to a safe and busy construction season this year.

- He thanked the Rochester Hills Government Youth Council and Avondale Honors Society for assembling over 1,700 Senior Wellness Packets. He shared that the distribution of the Senior Wellness Packets is a way to reach out and support the senior community within the City. He stated that the packets included information on local parks, things to see and do in the City and information on City services.

- He provided an update from Beaumont Hospital on COVID-19. He stated that positive COVID cases have been trending down in the last three days. He shared that there have been quite a few employees on sick leave with COVID. He encouraged everyone to remain vigilant and continue to follow the orders of the Michigan Department of Health and Human Services. He shared that 34 percent of those in the State of Michigan are fully vaccinated and almost 50 percent of people have had their first dose of the vaccine.

- He expressed his support and prayers to all communities of people that live in the City of Rochester Hills and for the Oakland County Sheriff's Department. He shared that he released a statement last week when the verdict of the George Floyd case was read and expressed the importance of moving forward as a community that respect one another within the community, respect the sanctity of life, and honor the men and women that serve.

- He shared that last week the Mayor's Business Council hosted a special guest, Suze Orman, Financial Advisor, Author and Podcast Host. Ms. Orman engaged with the members of the business community, Rochester Hills employees and City Council to discuss financial freedom.

- He stated that he had the opportunity to interview Fiona Turett, NASA Flight Director on his Podcast, Right Down the Street, which airs today. He shared that Fiona Turett is a Rochester High School graduate and is in charge of all space communication on behalf of the United States.

- He shared that the State Census Data was released today and stated that Michigan will be losing a Congressional Seat. He noted that the State of Michigan's population grew at two percent, while the national average was approximately seven and-a-half percent. He stated that this means the State of Michigan will have one less Congressional Seat and one less Congressional District. He noted that the Independent Citizens Redistricting Commission will have a challenge in redrawing the district lines going from 14 to 13 districts. He stated that the City of Rochester Hills did their part in encouraging residents to complete the census.

- He recognized two former Rochester Hills natives; Brad Kozlowski who won the Geico 500 NASCAR race and Dez Linden who broke the world record in the 50k Ultramarathon running at a 5:45 average pace. He congratulated both former Rochester Hills residents.
