

CITY OF ROCHESTER HILLS OPEN SPACE PETITION

We, the undersigned, registered and qualified voters of the City of Rochester Hills, residents in the County of Oakland, State of Michigan, respectively petition for this said proposal.

Shall the City of Rochester Hills levy a new millage of up to one-half (0.50) mill (\$0.50 per \$1,000 of taxable value) on the taxable value of all property assessed for taxes in the City for a period of ten (10) years, beginning in 2004 and continuing through 2013, inclusive, for the purpose of providing funds for the acquisition of land for the protection of natural habitat and the preservation of green spaces in the City? The estimated amount of revenue that will be collected in the first year if the millage is authorized and levied in full is One Million Six Hundred Thousand Dollars (\$1,600,000).
