**SUBJECT:** Relocation and re-establishment fees associated with Adams Road Relocation Project

## **REQUEST:**

The Department of Planning and Development is requesting that City Council approve the attached Resolution accepting the proposed invoice and authorizing the payment for relocation and re-establishment fees for Trans-Industries, in association with the Adams Road Relocation Project.

## **REASON FOR PURCHASE:**

Costs incurred by a company that relocates due to the eventual right-of-way acquisition are subject to reimbursement under the standards of the FHWA and the laws of the State of Michigan. Trans-Industries was located in the building owned by Asher Tadian that is identified as the only "total take" to accommodate the relocation of Adams Road. These costs were not and could not be identified until the actual move occurred and receipts tracked. Copies are included as part of this packet. Our acquisition agents and our condemnation attorney have scrutinized these receipts as being reasonable. These costs will be paid out of the LDFA fund just as the costs for the right-of-way. The specific costs to reimburse Trans-Industries has not been discussed with the City Council, however, Council has been previously advised in very general terms that relocation costs were also the City's responsibility with right-of-way acquisition.
