EDUCATION Graduated from High School in 1955 in top 5%. Attended Lawrence Tech. Institute full time in 1955-56 and night school in 1957. Attended extension courses at Univ. of Det. Michigan State Univ. Univ. of Michigan, Oakland Univ. Wayne State Univ. and Univ. of Arizona. Some of the courses taken are Sales, Sales Mgt. Marketing, Business Admin. Accounting, Public Speaking, Economics, Computer Operation, Computer Programming, Metal Machining, Tool Design, Statistical Process Control, Total Quality Mgt. Cold Forming, Abrasives- Coated and Bonded, Casting using Lost Wax Process, Jewelry Making, Jewelry Design , Stone Setting and Heat Treat.

1956 thru 1958 Wilson-Garner Company
Truck Driver – Warehouse Manager

I drove from 1956 through 1957 and was promoted to the warehouse. In early 1958 I was promoted to Warehouse Manager. Wilson-Garner was a manufacturer and a distributor of cutting tools and a manufacturer of fasteners.

1958 thru 1960 U.S. Army

In November of 1958 I was drafted into the U.S. Army. I served from November 1958 through November 1960. I applied for Officers Candidate School and was accepted but decided not to go. It would have required that I stay in the service for almost another year. I was sent to Germany in June 1959 and worked in operations and intelligence of an armored infantry battalion until November 1960. I held a Secret security clearance for my job and attained a rank of Spec. 4 prior to an honorable discharge. Although my rank was Spec. 4, I was performing the job of a Sgt. First Class which is two grades higher in rank.

1960 thru 1963 Wilson-Garner Company
Office Manager

I returned to Wilson-Garner Co. immediately after my discharge, to a position in the Order Dept. In 1961, I was appointed Office Manager. I was responsible for all office functions and the warehouse.

1963 thru 1971 Wilson-Garner Company
Sales – Sales Manager

In 1963, I went into outside sales and at that time also held a position as a Tool Designer. By 1966, I was Sales Manager of the company. I remained Sales Manager until 1971.

1971 thru 1979 Wilson-Garner Company
Vice-President of Sales/ Owner

In 1971, a partner and I purchased Wilson-Garner Company. I became Vice-President of Sales and 50% owner of the company and was responsible for all sales and profitability of the company.

I remained an owner of the company until 1979, when I sold my interest to my partner with a contract for me to represent the company for ten years as a Manufacturers Representative on a commission basis. When my partner and I purchased the company we were doing approximately one million dollars a year in sales. When I sold my interest, our sales were approximately nine million dollars a year. During this period we purchased two other companies and began manufacturing fasteners. After the sale of my interest, my main effort was to develop the sale of fasteners manufactured at W-G Cold Formed Products.

1973 thru 1989 W-G Cold Formed Products
Vice-President/ Owner

In 1973 three individuals, including myself, formed W-G Cold Formed Products. W-G was a manufacturer of Bolts ¼" through 1-1/4" in diameter, Hex Cap Screws, Place Bolts and Special Bolts.

I was Vice-President of W-G Cold Formed Products from 1973 through 1989 when the company was sold to Wilson-Garner Company. I had been totally responsible for sales and profitability. When we began W-G sales were zero and by 1991 had rose to 1.6 million dollars with a gross margin of 50%. Wilson-Garner Company was the exclusive sales agent for W-G Cold Formed Products.

1979 thru 1995 Multi-Spectra Corporation
President/ Owner

I formed a sales agency called Multi-Spectra Corporation (this was concurrent with being V.P. of Wilson-Garner and V.P. of W-G Cold Formed Products). At my peak I had about 2.5 million dollars a year in sales that generated approximately \$200,000 in commissions. I represented Wilson-Garner Co. John Deere Co. Standard Locknut and BTM Inc. I sold proto-type, short run and production fasteners along with screw machine parts and bent wire forms.
