### PLEDGE OF ALLEGIANCE

**President Tisdel** introduced Jenny Brown, Katie Albano, and Rebecca Smither of Dutton Farm and stated they will lead us in the pledge this evening.

**Jenny Brown** stated they are from Dutton Farm and shared that Dutton Farm works to empower and support adults with disabilities to live a life of purpose, inclusion, and dignity. She noted their goal is for individuals to find their gifts and use them to better the community. She thanked everyone for having them.

**Mayor Barnett** mentioned that earlier this evening the City did an unveiling of the artwork done by Ms. Albano and Ms. Smither. He encouraged everyone to check out their spectacular art by the Assessing Office. He noted the artwork is for sale with the proceeds going to Dutton Farm.

## COUNCIL AND YOUTH COMMITTEE REPORTS

### Rochester Hills Government Youth Council (RHGYC):

Mr. Deel introduced Maya Iyer, RHGYC Representative.

Ms. Iyer stated she is a student from Rochester High School and has been a member on Youth Council for 2 years. She mentioned the Rochester Hills Government Youth Council is currently planning various projects to carry out throughout the next few months. She noted they will be active at the local middle schools in the beginning of April, recruiting for the next youth council term.

### Green Space Advisory Board:

Dr. Bowyer mentioned to save the date for Saturday May 4th for the Discovery Hike at the Hardening Green Space, just off the Clinton River Trail north of Rochester College.

### Paint Creek Trailways Commission:

She reminded everyone that the bridge on the Paint Creek Trailways is being replaced. The trail between Silverbell and Dutton will be closed from June 1st until mid-September. The trail is also being repaved so there will be 1 mile closures at a time. She suggested going to [paintcreektrail.org](http://paintcreektrail.org) to check for updates.

### SEMCOG:

Mr. Hetrick stated Mayor Barnett was elected to the Executive Committee for SEMCOG and as such he will represent all of the cities in Oakland County. He also mentioned that he was elected as the alternative to the SEMCOG Executive Committee.

### Older Persons' Commission (OPC):

Mr. Kubicina announced the following upcoming OPC events:

**Ken Elwert**, Parks & Natural Resources Director, stated the City is proposing to once again apply for a grant through the National Parks Service. He mentioned that this is the same grant that the City applied for and was granted in 2016 and 2017. He explained that this grant is funded through royalties from the National Parks Service programs; it is not funded from tax dollars. He noted that the grant amount that is available has doubled from \$150,000.00 to \$300,000.00 and stated that if the City is awarded the grant, it will be utilized towards the construction of a playground at Innovation Hills Park. He pointed out that if the City is awarded the grant, it should come in around January 2020 and mentioned that this would allow construction of the playground to begin in the Fall of 2020.

**Whereas**, if awarded the grant, the City would competitively bid and purchase the materials and installation with reimbursement by the Michigan Department of Natural Resources of the grant amount upon completion; and

In attendance were **Sara Roediger**, Planning & Economic Director, **Eric Bell**, Goldberg Companies, **Gary Ogorocki** and **Tom Nester**, Dimit Architects, **Lynn Wipple** and **Rachael Smith**, PEA Consulting, and **Tom Wackerman**, ASTI Environmental.

**Ms. Roediger** stated this is a project that Council is very familiar with and tonight they will be discussing the final site plan. She mentioned a Consent Judgement was approved in 2006, which was amended last year into what they feel is a much better plan; allowing 368 residential apartments and improved environmental clean-up. She noted the site plan which now proposes a 359 multifamily unit went to Planning Commission last week and was recommended unanimously for approval. A tree removal permit was also approved. She mentioned two conditions were added by the Planning Commission; the addition of evergreen trees and some clarification on grading. She noted the staff has reviewed the site plan and finds it to be in compliance with the approved Consent Judgement.

**Mr. Bell** stated the Planning Commission was really complimentary of the design and the styling of the site plan. He noted the team worked hard to accommodate the City and the neighbors.

**Mr. Ogorocki** reviewed the site plan. He stated the site has nine (9) buildings in total. These buildings will be tudor-style architecture with dormers; utilizing brick, stone and stucco materials. He pointed out that the buildings are lower in height at the north end of the site near the residential area, and get a little taller on the southern portion of the site, closer to Hamlin Road. He noted buildings 1-4 are 2-story buildings with garages on the bottom and apartments on top. He stated buildings 5 and 7 are 3-4 stories high, still maintaining the garage on the bottom. He mentioned building 6 is the largest of the buildings and will be 4 stories high with underground parking. Building 6 is also where the Club

*House/amenity space will be. He explained that the amenity space is a signature feature of the development, including community rooms, lounges, and activity areas built with very nice materials. It will also have a resort style pool, exercise room and space to do yoga. The remaining two buildings are carriage-type buildings which are smaller buildings with garages on the ground floor and duplex unit arrangements above. He also showed the plans for the dog spa/maintenance building, and the mail kiosk. He mentioned the entrance sign will be at the corner of Hamlin and Adams Roads. It will read Legacy | Rochester Hills and will include a waterfall feature and the City of Rochester Hills logo.*

**Ed Baron**, 3310 Greenspring Ln., stated he has addressed his concerns to the Brownfield Authority, Planning Commission, and Council and is now moving forward to the Michigan Department of Environmental Quality (MDEQ). He mentioned they are part of the process and certain items have to be satisfied from the applicant to the state of MI. He noted he was impressed by Vice President Morita at Planning Commission because she seemed sincerely concerned about the residents and their health and safety.

**Ms. Wipple** stated there is now a buffer along the entire encapsulated area of evergreen trees. She also mentioned there is going to be a 4-ft tall native prairie grass and flower mix over the encapsulated area to deter residents from that area. She pointed out that overall there will be 118 evergreen trees in addition to the required buffer trees.

**Ms. Smith** mentioned the storm water drainage has been updated. She noted there is a swale on both sides of the berm to keep everything flowing towards Innovation Hills Park.

**Vice President Morita** thanked the Goldberg team for being so responsive to Planning Commission's concerns and making the changes so quickly. She also thanked Mr. Baron for his kind words, stating there is fine line between being on Council and Planning Commission and making sure the residents' concerns are heard, as well as protecting the City's interests as a whole. She mentioned she likes the design and feels it is harmonious with the surrounding subdivision.

**Dr. Bowyer** noted she feels the plan fits well with the area. She referred to the review letter and mentioned her concerns regarding finalizing the environmental cleanup and questioned if the regular checking of the vents would be covered.

**Mr. Wackerman** stated that is going to be covered in their documentation of due care compliance that will be submitted to the MDEQ for review and approval. He noted that document will have all the procedures that they will put in place for operation and maintenance of the encapsulated area. He noted they talked about frequency, the heights of the vents, and the purpose of the vents.

**Dr. Bowyer** noted she appreciates the site being cleaned up to a residential standard and making sure the other area is totally encapsulated and monitored.

**Mr. Hetrick** mentioned he appreciates the Goldberg team and the relationships they have built with the residents and the City. He thanked the team for cleaning up the site and preparing it for more residential opportunities.

**Mayor Barnett** mentioned tonight is significant in the process of this project and it is the result of a lot of work from the Goldberg team and the City's team. He noted this parcel had been empty for a long time and the teams worked together to come up with a vision and a plan, while engaging the residents. He also thanked the Council for their support. He stated the Goldberg team has been great to work with and the City will look for continued partnership as this project develops. He thanked Vice President Morita recognizing that it has been difficult for her to vote on this complicated project as she lives right next to it. He mentioned her questions have been focused and caused the developer to improve his product. He noted ultimately this is a project for the residents.

**President Tisdell** mentioned the MDEQ is under more scrutiny and pressure to perform, which means the Goldberg team will have to be at the top of their game.

**Mr. Wackerman** reiterated the MDEQ is going to be reviewing and hopefully blessing the no further action letter for the residential portion and the documentation of due care compliance for Parcel "B".

**Sara Roediger**, Planning & Economic Director, stated this item relates to the Legacy Project. She noted that consistent with the approved Brownfield Plan that we have for this site, the encapsulation area goes to the edge of the property. She mentioned that in order to construct the encapsulation wall there needs to be a temporary construction easement across Innovation Hills Park, fourteen feet of the western most edge of the property. This temporary license agreement will allow the applicant to work on the site until they get the job done, or until August 30th at the latest. She commented that they have worked closely with Ken Elwert and his staff to coordinate this construction with the work scheduled to take place at Innovation Hills Park. She mentioned a handful of

*trees will be removed, however, the Innovation Hills site did receive a tree removal permit as part of their construction plan and this fits within the tree removal permit.*

**Ryan Smith**, 1475 Dawes Ave., questioned if Captain Johnson and Chief Canto were asked if their staff could utilize these homes for hands-on training that would benefit the City. He inquired if the City is just going to take an excavator to the houses without recycling the materials. He noted many organizations

*could use those windows, cabinets, furnace, air condition units, etc. He mentioned the landscape elements could be salvaged and incorporated into the roundabouts, the splash pad area, or the pocket parks. He stated this is the City's chance to be innovative by nature.*

**Mr. Schneck** stated he had consulted with both Chief Canto and Captain Johnson, however, based on the need to get these structures down quickly and in an efficient manner, they chose not to use them for training. He noted there is asbestos in these structures and that would prohibit items from being incorporated in the streetscapes.

**President Tisdell** mentioned deconstructing sounds like a wonderful idea, but it can get more complicated when you have to store the items and then find a market for them.

## LEGISLATIVE & ADMINISTRATIVE COMMENTS

**Vice President Morita** referred to an earlier comment regarding the Legacy Project, and stated that her neighbors have been very kind and cognizant of her privacy, only coming over at set meeting times to discuss the project. She commented that it has been hard, but at the same time she is glad she lives right there because it has led to some really great conversations with staff and has headed off a lot of issues. She thanked Ms. Roediger and Mr. Davis for taking end of the day phone calls from her and explaining what is going on so she can then explain it to her neighbors. She thanked the developer and the Mayor for listening to her ideas and meeting with the residents first before Council made a decision. She noted this helped residents feel like they had more control and helped eliminate some fears.

**Dr. Bowyer** put in a plug for Dutton Farm, stating they make some of the best soaps. She encouraged people to consider purchasing their soaps or some of the other products they have for sale.

**Dr. Bowyer** noted the following events:

- HOA Leadership FORUM on Thursday, April 4, 2019 at 6:30 p.m. in the City Council Auditorium. Updates will be given on what is going on in the City and how they can better help the residents in our home owners association.

**Dr. Bowyer** mentioned if anyone is interested in finding out what is going on in the City, go to the [rochesterhills.org](http://rochesterhills.org) website. She pulled up the website and walked everyone through how to look up a development project or a road construction project by clicking on the 'Living In' tab and then selecting 'Maps'. She explained that by selecting 'Planning & Economic Development' options will appear for things like 'Development Projects' or 'Capital Improvement Plan' projects going on throughout the City.

**President Tisdell** mentioned that everything on the website is what the Council receives.

**Mr. Deel** thanked Katie Albano and Rebecca Smither from Dutton Farm for their art work and encouraged anyone who comes by City Hall to stop and look at it, and noted it was really great to meet the artists. He suggested that everyone should go visit Dutton Farm, noting it is a really great facility.

He mentioned the Sap to Syrup Pancake Breakfast was a fantastic event.

He stated there will be a Public Meeting on Wednesday, April 10, 2019 from 4:00 pm. To 7:00 p.m. at the DPS Garage to update the residents on the Auburn Road Corridor Project. He highlighted that currently Consumers Energy is relocating their existing gas main and Detroit Edison is replacing and relocating some of their utility poles.

**Mr. Hetrick** mentioned that last week he attended the Legislative Affairs Committee sponsored by the Chamber of Commerce and they are stepping in to assist business owners in the Auburn Road Corridor area once construction starts, providing some best practices to help them through this time. He noted it is terrific to see the cooperation and collaboration for a project that is going to be transformative for the City. He commented that the paintings from Dutton Farm are terrific and encouraged everyone to take a moment and check them out.

**Mr. Kubicina** mentioned the Tiger's home opener is only 10 days away on April 4th. They play the Kansas City Royals at 1:10 p.m.

**Mayor Barnett** acknowledged the great teamwork that takes place here at the

*City and highlighting the following:*

*He received a thank you letter from a resident yesterday. He noted this resident was concerned that there was a lot of water collecting in her yard and requested that someone come out to make sure the sewer drain was not clogged. She expressed her gratitude for the thoughtfulness and professionalism provided by the City workers to her, as well as her neighbors.*

**Sara Roediger** mentioned that when a new development comes into the City it is not often that her department receives a thank you from the neighboring residents for their thoughtful review of a plan. She shared that this past Friday, however, some residents brought in chocolate chip cookies and thank you letters addressed to the Planning Commission and the Planning Staff in appreciation of their work on the Berkshire Development. She noted how much she and her staff appreciated this gesture.

**Mayor Barnett** mentioned that Mr. Schneck and his team picked up an award for the Eddington Realignment Project. He noted this project won Regional Project of the Year, and then went on to win State Project of the Year, and is now competing nationally for Project of the Year.

**Mayor Barnett** mentioned the following updates:

*He thanked Tom Talbert for helping create the tenants and structure for the Mayor's Diversity, Equity and Inclusion (DE&I) Committee. He stated this committee was put together last year to advise him on matters relating to diversity, equity and inclusion, and to examine the role that government can play in strengthening those connections. He mentioned the committee has met four times and is made up of individuals from a wide range of cultures, faiths, ethnicities, orientations, ages and backgrounds. He noted this group is made up of exceptional people who are very focused on the journey of becoming a more inclusive community. He stated the group discussed the City's strengths and weaknesses, as well as events and programming ideas. He shared the following events that were held recently: Approximately 190 city employees went to see the movie 'The Hate You Give' which evoked good conversations among the City's team.*

*The Rochester Hills Government Youth Council hosted a cultural event for the City employees and Council members.*

*Digging Into Diversity & Inclusion Breakfast, which focused on individuals with disabilities.*

*Unveiling artwork from Rebecca and Katie from Dutton Farm.*

*He shared the structure the committee has focused on when it comes to nurturing diversity: what the City Administration can do, what City Employees can do, and how we communicate as a City. He introduced Jenny Brown, C.E.O. and Founder of Dutton Farm, stating she is also a member of the DE&I Committee and asked her to share her perspective of the Committee.*

**Jenny Brown** thanked the Council for warmly welcoming Dutton Farm. She

*stated she is honored to be part of the Mayor's Advisory Committee on Diversity, Equity & Inclusion and believes that everything that has taken place tonight has sent the message that Rochester Hills wants to be known for being an inclusive city. She mentioned that she is excited to work alongside such accomplished, talented people and to be part of something so innovative. She noted that the committee members are working on setting priorities, identifying where the gaps are in the community and how they can problem solve and set goals for closing those gaps. She commented that although the committee has made a lot of progress, they still have work to do. She stressed again how welcoming the Mayor and Council Members have been, and noted this effort starts with the leadership and stated the City is doing well.*

**Mayor Barnett** thanked Jenny Brown for being there. He noted he feels the City is on the right path, but mentioned that this is a journey to become a more inclusive and diverse City. He stated the City will continue to challenge themselves. He thanked the entire 15 member committee, including Vice President Morita, mentioning they are really exceptional people. He stated he will provide a report during third quarter to inform Council the direction of the committee, but is very pleased with the progress so far.

**Allan Schneck**, Public Services Director, stated this item is part of Phase I of the Auburn Road Project. He noted that they are aware of the budget concern and mentioned the following as ways than plan to tackle that issue:

They have applied for the Local Road Improvement Matching Fund Pilot Program through Oakland County. He mentioned the City's match to that program is \$136,625.00.

Due to good project management, the City typically does not dip into the contingency funds included for a project. The contingency amount for this project is \$231,770.22.

He stated they have also applied for a grant through SEMCOG called the Green Infrastructure Implementation Grant in the amount of \$50,000.00. Although not all \$50,000.00 would be attributable to the alley and parking lot work, the amount that is would be offsetting revenue.

There will be a favorable seven figure number coming before Council as part of the 2nd Quarter Budget Amendment for Local Roads.

**Vice President Morita** questioned why there was only one bid.

**Mr. Schneck** stated Ms. Cummins contacted a couple of potential vendors, however, based on the deadline for completion and the scope of the work, the



City did only have one vendor bid.

**Vice President Morita** asked if the City is expecting to only see one bid on future projects.

**Mr. Schneck** responded that based on the shutdown that occurred last year there is a lot of work that still needs to be completed and contractors are being selective on which projects they want to bid on. However, he anticipates the April 5th bidding opening for the Auburn Road Project will have multiple bidders.

**Vice President Morita** asked if this was for Phase 1.

**Mr. Schneck** stated that is correct.

**Mr. Hetrick** stated that on the agenda summary there is about \$165,000.00 in overage. He questioned if not having to use the contingency, and the \$135,000.00 from the Oakland County Pilot Program, would that eliminate the majority of the overage.

**Mr. Davis** stated that what is before Council is to enter into an inter-local agreement with Michigan Department of Transportation (MDOT) on the Phase 2 portion of the Auburn Road Project. He mentioned this is typical of MDOT to require an agreement, even before receiving the bids. The bid is scheduled for April 5th. He noted the agreement is based on the engineers estimate for the project. He mentioned the City inquired whether an amended agreement would need to be done with MDOT if the bid come in differently then what was estimated, and were told that is very rare for that to happen. He stated this is an advanced construct project and MDOT is requiring a deposit on this of \$375,000.00.

**Mr. Schneck** stressed that there has been a lot work to get fund balances in place. He noted the negotiation with MDOT on the conveyance of Auburn Road provided funding. Also \$625,000.00 was provided for the South Boulevard project and \$700,000.00 for Livernois, which offset the City's participatory share so those funds can reside in Fund Balance. He mentioned based upon a motion by the City the Federal Aide Committee approved moving up the federal aid dollars from 2021 to 2020, which makes the City's reimbursement eligible for the fall of 2019.

**President Tisdel** mentioned capacity and pricing is an issue. He noted it was

*not a shock that Pro-Line was the only bidder that had the capacity and ability to complete the road on time.*
