**REQUEST:**

That the Rochester Hills City Council approves the Cost Participation Agreement for Phase Z Force Account Work between the Road Commission for Oakland County (RCOC) and the City of Rochester Hills for the Crooks Road reconstruction and widening project between Auburn Road and Hamlin Road and authorizes the Mayor and Clerk to execute the agreement on behalf of the City.

**REASON FOR PURCHASE:**

The RCOC has prepared a cost participation agreement for utility relocation construction to be provided by DTE Energy in conjunction with the Crooks Road widening project. Through RCOC, Federal funding will be applied to eligible items of this work at a participation ratio of approximately 80%. RCOC and the City of Rochester Hills will share the local match of 20% equally. The total cost of the utility relocation includes total payments to the contractor, construction engineering and inspection costs along with temporary and permanent traffic controls. If overages to the project occur, RCOC and the City of Rochester Hills will share the costs equally.
