-95. COMPENSATION OF MEMBERS.

(A) *Title.* This section shall be known and cited as the "Boards and Commissions Compensation Ordinance."

(B) *Compensation prescribed.* The annual compensation for appointed members of boards and commissions of the city shall be as follows.

(1) *Building Authority.* Each member of the Building Authority shall be compensated \$15 per public meeting attended, but not more than \$180 per year. During periods of building constructed management for the city, to be determined by the City Manager, each member shall be compensated \$20 per public meeting attended with no maximum per year.

(2) *Code Board of Appeals.* Members shall be compensated \$30 per public meeting attended, but not more than \$90 per month.

(3) *Electrical Board of Examiners.* Members shall be compensated \$20 per public meeting attended, but not more than \$40 per month.

(4) *Property Maintenance Code Board of Appeals.* Members shall be compensated \$20 per public meeting attended, but not more than \$40 per month.

(5) *Planning Commission.* Members shall be compensated \$30 per public meeting attended, but not more than \$90 per month.

(6) *Ordinance Appeals, Board of.* Members shall be compensated \$30 per public meeting attended, but not more than \$90 per month.

(7) *Review, Board of.* Members shall be compensated \$7.50 per hour, with a minimum of \$15 per day, for each public meeting attended, but not more than \$1,000 per member per fiscal year.

(8) *Zoning Appeals, Board of.* Members shall be compensated \$30 per public meeting attended, but not more than \$90 per month.

(C) *Others not compensated.* Unless otherwise provided, members of all other boards and commissions of the city shall serve without monetary compensation, except for reimbursement of reasonable expenses incurred in accordance with the terms and conditions of this section.
