PURPOSE:

City Council authorization of the purchase and delivery of electric energy for City facilities from DTE Energy, Detroit, Michigan and Michigan Municipal Risk Management Authority, Livonia, Michigan in the amount not-to-exceed \$390,950 through December 31, 2004.

DISCUSSION:

It is the goal of the Facilities Division to offset the ever-rising energy costs incurred by City facilities. As a member of the Michigan Municipal Risk Management Association (MMRMA) Electric Choice Program, the City participated in a joint community purchase for electrical power. The City will purchase its electrical energy for City Hall, Public Safety Building and the DPS Garage through the program from Quest Energy, Ann Arbor, Michigan. The delivery of electricity will continue to be provided by DTE Energy. The projected savings for electric energy for these three large facilities is estimated at 18% or up to \$30,000. MMRMA will impose a \$.006 per kilowatt hour administration fee.

The smaller City facilities will not benefit from the cost savings of the larger buildings and will continue to receive electrical energy and its delivery from DTE Energy.

The estimate for electrical energy consumption by City facilities, including the addition to City Hall is \$390,950. Due to participation in the MMRMA Electric Choice Program, payment for electrical energy and delivery will be made to MMRMA and DTE Energy.
