## **REQUEST:**

To provide City Council members with information for nomination of two (2) Citizen Representatives to the Board of Trustees to the Retiree Health Care Trust.

## **BACKGROUND:**

City Council, at their June 29, 2009, Regular Meeting, voted to create the Board of Trustees to the Retiree Health Care Trust with membership to consist of the following:

City Council – One (1) Member

**Citizen Representatives** – Two (2) Members. Committee shall include citizen members which shall be appointed by Council.

**Administrative Representatives** – City Treasurer and City Finance Director.

Each Trustee shall be a fiduciary and have fiduciary responsibilities under applicable law and shall act prudently and in the best interests of the Trust. Each Trustee will receive and hold the Trust as Trustees by virtue of the terms, conditions and provisions of the Trust and for the purposes, uses and trusts and with the powers and duties set forth by the Trust.

A Notice of Vacancy for the Board of Trustees to the Retiree Health Care Trust was posted at City Hall, Rochester Hills Public Library, City Web Page and Cable Channels. Interested residents had until July 17, 2009 to submit a Board of Trustees to the Retiree Health Care Trust Candidate Questionnaire. City Council removed this item from the July 27, 2009 Agenda to extend the date for Candidate Questionnaire submission to August 11, 2009.
