Whereas, the contract with Steele's Services, LLC offers value to the City through price and the quality of service; and

Whereas, the City wishes to exercise its option to renew through October 15, 2006;

Resolved, that the Rochester Hills City Council hereby authorizes a Blanket Purchase Order to Steele's Services, LLC, of Rochester Hills, Michigan, for the purchase of snow removal services at City Hall,

Precinct #5; and 1700 & 1600 Hamlin West, in the amount not-to-exceed of \$31,133 through October 15, 2006.

Further Resolved, that the Mayor be authorized to execute the contract on behalf of the City.
