**REQUEST:**

City Council is being requested to enter into the 2011 Oakland County Household Hazardous Waste (No Haz) inter-local agreement between Oakland County and the City of Rochester Hills in the not-to-exceed amount of \$50,000. This total requested amount would include the estimated proceeds from a \$10.00 per vehicle charge to residents.

**REASON FOR PURCHASE:**

In 2010, Oakland County continued its coordination and agreement with the consortium of eight (8) communities to provide a comprehensive household hazardous waste collection program. Because of the reduced number of participating communities and the implementation of several communities charging a supplemental \$10.00 fee to their participating residents, the projected results seemed uncertain. The end result was an overall decrease of 54% in the number of participants. However, there was an average increase of 19% in the average weight of the materials brought from each individual household. This would suggest that participants are now beginning to attend one event per season rather than bringing items to multiple events thereby reducing the overall per household cost.

In 2010 there were four (4) No-Haz collection events. Due to the experienced and anticipated reduction in the number of participants, the 2011 budgeted amount of \$47,531.21 would include the present eight (8) participating communities and three rather than four events. This amount also includes the anticipated continuation of \$10.00 per household charge for participants.
