

COST PARTICIPATION AGREEMENT

This Agreement is entered into on _____, 2015, between the City of Rochester Hills, a Michigan municipal corporation, of 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309 and the City of Rochester, a Michigan municipal corporation, of 400 Sixth Street, Rochester, Michigan, 48307 and the City of Auburn Hills, a Michigan municipal corporation, of 1827 N. Squirrel Rd, Auburn Hills, MI 48326.

WHEREAS, the three (3) Cities have secured a Michigan Department of Transportation (MDOT) grant through the Southeast Michigan Council of Governments Transportation Alternatives Program (SEMCOG) for the Clinton River Trail Look & Feel Safety Improvements to provide signs and other amenities along the Clinton River Trail through their communities; and

WHEREAS, upon completion, this project will develop trail amenities, safety, and interpretive exhibits along 9.3 miles of the Clinton River Trail. The project will include informational kiosks, road crossing signage, wayfinding, interpretive signage, bike racks, two shade shelters, monument signage, picnic tables, trash receptacles, and pavement markings.

WHEREAS, through this Agreement, the City of Rochester Hills, the City of Rochester and the City of Auburn Hills desire to commit their oral understanding to writing concerning how the Design and Construction Engineering Services costs will be apportioned.

THEREFORE,

1. Anderson, Eckstein and Westrick, Inc., 51301 Schoenherr Road, Shelby Twp., Michigan has proposed to provide construction administration, assistance with grant administration, construction staking, construction inspection and prepare as-builts upon completion of the work.

The consulting services fee of \$29,500.00 is proposed on a lump sum basis.

2. Upon completion, the City of Rochester Hills will pay Anderson, Eckstein and Westrick, Inc. for one hundred percent (100%) of the actual costs associated with the construction engineering; and invoice the City of Rochester for \$13,275.00 and the City of Auburn Hills for \$7,670.00. The City of Rochester and the City of Auburn Hills shall pay the invoice within thirty (30) days of receipt of same.
