## **REQUEST:**

City Council is requested to authorize a blanket purchase order/contract for the construction of a new roof access hatch and stair case for the Department of Public Services Facility to Hittle Construction Co., White Lake, Michigan in the amount of \$36,979.00 with a 5% contingency of \$1,848.95 for a total not-to-exceed amount of \$38,827.95 and authorize the Mayor to execute a contract on behalf of the City.

#### **REASON FOR PURCHASE:**

The City issued a Request for Proposals for the construction of a new roof access hatch and stair case for the DPS Facility, utilizing the MITN system and one (1) proposal response was received. City staff evaluated and scored the proposal and verified references. It is recommended an award be made to Hittle Construction based upon the proposal submittal, work plan and quality of work by verification of references.

When evaluating the project, it was noted that the project came in over the budget amount the City had anticipated for the work. The City engaged in negotiations with the Proposer to determine if there was any cost saving measures they could take to bring the project more closely in line with budget. After several negotiations and considerations of different options, the vendor agreed to provide a deduction of \$3,500.00 if the City performed all the painting restoration work required for the project.
