Dear Chief Crowell.

Thank you for your continued interest in Halt Fire and Pierce Manufacturing. Per your request, I have updated the proposals for the three (3) Pierce Manufacturing stock fire apparatus. This includes two (2) Contender series PUC pumpers and one (1) 75' Heavy-duty Aluminum Ladder (HAL) quint.

Enclosed you will find a short component list describing each vehicle. I have also listed below any items that are included with the price of corresponding vehicle.

CONTENDER SERIES PUC PUMPERS - JOB 20712 & 20713

Both stock units 20712 & 20713 have been revised with your requested changes. Both trucks are identical and would be tentatively completed in the November/December time frame based on the additional equipment your department would like to add. I can provide a more detailed scheduled as we move forward.

The current price for <u>each</u> Contender PUC pumper is \$323,187.00. This price includes the following:

- One inspection trip for three (3) people
- · Delivery of the completed vehicle back to Michigan
- A post delivery inspection performed by our service department
- One (1) day of vehicle training for your department
- A contingency fund of \$2000.00 (Any amount not used will be subtracted from the final invoice)
- Loose equipment for the vehicle including external intake relief valve and pump panel hose adapters with Detroit Standard threads.
- Removing hydraulic rescue reels from your current apparatus and reinstall those in the new PUC pumpers.

IMPEL CHASSIS 75' ALUMINUM LADDER QUINT - JOB 20887

Stock unit 20887 has been revised with your requested changes. This unit would be tentatively completed in the November/December time frame based on the additional equipment your department would like to add. I can provide a more detailed scheduled as we move forward.

- A contingency fund of \$2000.00 (Any amount not used will be subtracted from the final invoice)
- A lettering and graphics allowance of \$2500.00

Please be aware that all three vehicles being considered are stock demo units and are on a "First come, First serve" basis and can be sold at any time. Only a signed Pierce contract will hold the vehicle(s). If in the event one of the above vehicles is sold, I will have to research and see if there are other stock demo units available that meet your core requirements as well as get engineering approval for your additional add-on equipment. This may result in a vehicle higher in price and may have a longer lead time depending on availability.
