SUBJECT: Architectural and Engineering Services for Oakland County Sheriff's Office Renovations

REQUEST:

City Council is requested to authorize a contract / blanket purchase order for Architectural / Engineering services for the Oakland County Sheriff's Office Renovations Project in the amount not-to-exceed \$120,300.00 to A3C **Collaborative** Architecture, Ann Arbor, Michigan and further authorizes the Mayor to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

A3C Collaborative Architecture is one of three (3) on-call architectural/engineering firms that were qualified through a Request for Proposal process completed by the City last year to provide on-call as needed architectural/engineering services, similar to how the City handles their engineering firms. The City, through an RFP process received nine (9) proposal responses. A committee consisting of staff from Facilities, Building, Parks, and the Fire Department evaluated the responses and subsequently shortlisted and interviewed five (5) firms. Based on the interviews and proposals received, the committee recommended retaining the services of three firms, A3C, Niagara Murano, and DLZ. These firms were selected based on their varying areas of expertise, proposed staff, and overall best value cost schedules. A3C was selected to perform the architectural and engineering services for the OCSO project based on their past experience with similar projects.

This project consists of renovation and updates to the Detective Bureau, intake and holding areas, Interview Rooms, Squad Room Workstations, lobby/intake areas, and the south side of the existing office which will include the administration areas, roll call area, employee lounge and locker/bathroom areas. The project will be completed in coordination with a construction manager to oversee and manage the project. The purpose of this project is to bring it up to current standards and needs, to better assist with public interface, staff and public safety, and staff retention and satisfaction.
