SUBJECT: RCOC Cost Participation Agreement and Corridor Analysis for Avon Rd/Dequindre Rd/
23 Mile Road near the Yates Cider Mill; City File No. E17-018

REQUEST:

The Department of Public Services requests that the City Council approve a cost participation agreement with the Board of County Road Commissioners of the County of Oakland, Michigan, to study the Avon/Dequindre 23 Mile Road corridor by Yates Cider Mill in the amount of \$15,000.00 and authorize the Mayor to execute the contract on behalf of the City.

REASON FOR PURCHASE:

The Great Lakes Water Authority (GLWA) is planning to relocate a 96-inch water transmission main along portions of Avon and Dequindre Road by the Yates Cider Mill. Since the new water main will affect the existing road section, the Road Commission for Oakland County (RCOC) is taking the opportunity to review options and coordinate roadway improvements for Avon and Dequindre. The RCOC has already secured funding for the reconstruction of the Avon Road bridge crossing of the Clinton River west of Yates Cider Mill and an option to construct roundabouts at the Avon/Dequindre and Avon/23 Mile intersections is being considered.

The attached cost participation agreement will assist the RCOC in planning for roadway improvements or changes that can be included in the GLWA water main relocation project. Other agencies that are proposed to participate in cost sharing for the agreement include the City of Rochester and the Macomb County Department of Roads (MCDR).
