SUBJECT: Revised Easement for Property Owned by the City of Rochester Hills Adjacent to the Stan's Trucking Landfill Facility, Oakland County,

Site ID No. 63000062

Property Tax ID No. 15-24-401-048

Enclosed is a revised Grant of Easement (Easement) for an 8.89-acre property that the City of Rochester Hills owns (Property) and is associated with Stan's Trucking Landfill Facility, located on School Road, Rochester Hills, Macomb County, Michigan. The full legal description of the Property is included as an attachment to the Easement. This letter, which is a follow up to an earlier letter dated March 17, 2004, is being sent to request that you, as an authorized representative of the City of Rochester Hills, sign the Easement to provide the Department of Environmental Quality (DEQ) access to the Property. Language in Paragraph 3 of the enclosed Easement has been somewhat modified and is now mutually agreeable after discussions between your counsel. Mr. John Staran, and our counsel, Mr. James L. Stropkai, Assistant Attorney General. Please disregard the previous easement you received with the DEQ's March 17, 2004. letter and instead execute the Easement enclosed.

The Easement is needed to ensure that the DEQ and its successors and assigns will have future access to the Property as needed for performance of response activities. including operation and maintenance activities, to protect the public health, safety, and welfare, and the environment. Sections 20117(3)(e) and 20118 of Part 2011 and the Part 201 Administrative Rules, provides authority for the DEQ to conduct necessary response activities at Stan's Trucking Landfill Facility, which includes all or portions of the Property delineated in the property description provided with the Easement. The Easement will allow the DEQ to retain access to the Property until all response activities have been concluded.

Once you have executed the Easement, please see that the Easement, along with a record containing the City Council's authorization for the Easement, is returned to Ms. Jacqueline Barnett of my staff. Ms. Barnett will see that the Easement and the authorization are recorded and will send a copy of each document to you for placement in your files when she receives the recorded documents from the Oakland County Register of Deeds.
