# **PUBLIC COMMENT**

**Ms. Deanna Hilbert**, 3234 Quail Ridge, Chair of Citizens Voice Rochester Hills, made the following statements regarding the REI/Madison Park development:

<sup>\*</sup> The landfill has been taken off a Michigan Department of Environmental Quality (MDEQ) "hit list" of sites of high concern.

- \* The contamination claims made by REI and the City Council have not been supported by subsequent testing of the area.
- \* The MDEQ is concerned over the size of the remediation.
- \* Remediation time will be longer than is claimed by REI.
- \* An REI representative stated at a Brownfield Redevelopment Authority meeting that the methane is not a great concern.
- \* Senator Bishop claims he was given misinformation about the hazards and conditions of the landfill site.

Ms. Hilbert asked the following questions:

- \* Was the Suburban Sports/REI proposal justified and rushed through on false environmental information?
- \* What is the Council's current understanding and assessment of the environmental status of the Suburban Sports property and landfill?

Ms. Lois Golden, 645 Apple Hill Lane, presented Council with what she described as "allegedly a concept plan for the REI/Madison Park proposal" indicating that the development would be primarily a retail development with one (1) office building. She noted the plan has been "circulating in the community" and she was asked to bring it to Council's attention. She asked what Council would do if it were determined this plan were legitimate. She further requested that, in the interest of "better communication, some of the Master Plan work shop meetings be televised."

**Mr. Lee Zendel**, 1575 Dutton Road, using the metaphor of a toothache, warned residents that the poor condition of the City's local streets will continue to deteriorate and, in the long run, cost the City more money in the future than if the problem were addressed by approving a local roads millage.

# LEGISLATIVE & ADMINISTRATIVE COMMENTS

Ms. Hill indicated that Council could not speculate on "rumored" plans for the REI development. She stressed that the proposed development is at the beginning of a long process. She stated it is unfortunate that so much "misinformation is out there." She stressed that she does not believe that anything was rushed through the process on false information and that all information has been "put out to the public." Ms. Hill thanked Council, stating she is honored to serve as Council President. She wished everyone happy holidays and thanked the Clerk's office and, in particular, the Council Liaison Team, for their assistance throughout the year.

Mayor Somerville briefly discussed the City's new snow plowing policy. She indicated that the changes were necessitated by the failure of the proposed local roads millage on the November ballot. She stressed that all roads will be plowed but at a slower rate due to budget cuts.

**Ms. Holder** described a flyer distributed in the community by the group Citizens Voice Rochester Hills. She praised their civic involvement but encouraged them and all citizens of Rochester Hills to get involved in local government and volunteer to serve on committees, boards and commissions. She further encouraged residents to contact their Council members directly to inquire about rumors in the community.

Mr. Barnett announced that the Community Development & Viability (CDV) Committee would be meeting the next evening to discuss the snow plowing policy. He encouraged interested residents to attend.

**Mr. Dalton** explained that the Financial Services Committee was exploring the possibility of using Tree Fund money to remove ash tree stumps resulting from the removal of Emerald Ash Borer-infested trees in front of residents' homes. Mr. Dalton further noted that, now that he is no longer Council President, he would like to encourage improved communication between himself and his constituents.

**Ms. Raschke** stressed that the recent failed millages "have hurt us." She further noted that, as a member of the Public Safety Committee, she will work to increase the number of firefighter/paramedics working for the City.

# **ATTORNEY MATTERS**

**City Attorney John Staran** noted that he had filed a motion on behalf of the City with the Oakland County Circuit Court to dismiss recent litigation regarding the property at the northeast corner of Adams and Hamlin Roads.

Mr. Paul Funk, 2176 Rochelle Park; Mr. Jack Robinson, 1251 Avon Circle East; and Mr. Jerry Carvey, 936 Ironstone, representing Save Open Space Rochester Hills (SOSRH), presented information they have gathered by reviewing the election results precinct by precinct regarding the failed open space millage:

- \* The proposal passed in nine (9) precincts.
- \* Forty-five percent (45%) of voters voted "yes" for the proposal.
- \* Several other City and State proposals on the ballot may have confused some voters.

- \* The number of "yes" votes received represents a substantial pool of potential supporters that could more than twice exceed the number of signatures needed to place the issue on a future ballot.
- \* Public support and involvement is still strong following the failed vote.
- \* Including preservation of some active open space may make the proposal "more palatable" in the future.

Mr. Funk asked Council to consider the following requests:

- 1) Continued Council support for this proposal.
- 2) Formally consider and adopt a citizens advisory committee that would review the recent land preservation program, both in scope and approach.
- 3) Support SOSRH's research on the approaches and results pursued by other communities that have been successful in this type of endeavor.
- 4) Put the issue on a future ballot without a "proposal signature phase" following the results of community awareness, education and feedback forums.
- Mr. Barnett praised their "sincere goal and realistic plan of attack" and suggested that the Community Development & Viability (CDV) Committee discuss the creation of this committee at their next meeting.
- Mr. Dalton expressed enthusiastic support for sending this matter to the CDV Committee and stressed that "the sands are running out for us to save these open spaces."

**Ms. Hill** suggested that the Leisure Activities Committee could provide some input into the creation of an open space committee.
