SUBJECT: RCOC and Rochester Hills Street Light Maintenance and Cost Sharing Agreement - Avon

and Dequindre Roundabout - City File E20-021

REQUEST:

City Council is requested to approve the Street Light Maintenance and Cost Sharing Agreement (AGREEMENT) between the City of Rochester Hills (CITY) and the Road Commission for Oakland County (RCOC) for the cost of ongoing energy, replacement, repair, inspection, maintenance and administration costs associated with the 8 street lights installed at the Avon and Dequindre Roundabout. Council further authorizes the Mayor to execute the Agreement on behalf of the City.

REASON FOR REQUEST:

This lighting has been installed at the newly constructed roundabout at Avon and Dequindre Roads. The lighting consist of eight (8) underground fed 136w LED Roadway Lights mounted on 22 foot Decorative New North Yorkshire Single Arm black posts.

The Purchase Agreement submitted by DTE on December 14, 2021 states the estimated annual Lamp charges is \$2,643.84, half of which will be subsequently billed to RCOC by the City.

According to the Agreement, in the event a Street Light is damaged or destroyed, the CITY shall purchase a replacement without undue delay and RCOC will be subsequently billed 50% of the replacement cost. RCOC shall forward payment to the City within 30 days of the billing. Should operating costs change, the share rate will remain constant, according to the Agreement.
