SUBJECT: Fire Suppression and Fire Alarm Plan Review

and Inspection Services for 2012 and 2013

REQUEST:

City Council is requested to authorize a blanket purchase order to Fire Safety Consultants, Inc. for Fire Suppression and Fire Alarm Plan Review & Inspection Services in the not-to-exceed total of \$100,000 (One Hundred Thousand) Dollars for a term to expire on December 31, 2013.

REASON FOR PURCHASE:

The City of Rochester Hills solicited proposals from qualified and experienced firms to assist the Building Department with fire suppression plan review and inspection services for commercial and industrial projects in accordance with the State of Michigan Construction Codes. The plan review and inspection fees are reimbursed to the City by commercial and industrial developers.

Request for proposals were opened and solicited on October 11, 2011, an Evaluation Team reviewed the proposals and Fire Safety Consultants was selected to perform the services for a two (2) year term to expire on December 31, 2013.

At this time, the City requires the services of Fire Safety Consultants to provide the necessary services and meet departmental demands. Building Department staff has provided these services in the past; however, at this time the Building Department does not have personnel qualified to perform this work.
